The league went on record as favoring the amendment proposed to th city charter of Salem to make the office of police chief appointive rather than elective, on the ground that if that official should be held directly responsive to the mayor and common council of the city of Salem instead of to ship. the electorate at large more efficient law enforcement could be se-
