

ONE MORE DAY

Jury in Kohler & Chase Against Alkire Unable to get Verdict Tuesday

Because the jury in the case of Kohler & Chase against D. S. Alkire, local dancing teacher, was unable to reach a verdict in the circuit court at a late hour yesterday afternoon, the case of Grace Libby against the Southern Pacific railroad, which is expected to create considerable attention, was delayed for another day. The latter case was originally set for last Monday but owing to a prolongation of the Alkire case, has been postponed for several days. It is expected, however, that selection of a jury in the Southern Pacific case will begin today.

The case of Kohler & Chase against Alkire arose through the purchase of a player piano by the defendant from the plaintiffs at a cost of \$875. The plaintiffs are suing for a balance still due on the piano of some \$583 while the defendant claimed that the piano was imperfect when purchased, resulting in considerable damage to himself, to the extent of \$475. The jury which retired at noon was still out late yesterday afternoon. A sealed verdict is expected this morning.

The case of Grace Libby against the Southern Pacific is for collection of \$250, the alleged worth of a truck destroyed when A. C. Libby was run down and killed by a Southern Pacific train at Jefferson. The railroad contends that the accident was due entirely to the negligence of the deceased while the plaintiff holds that the accident resulted through negligence on the part of the defendant. Ben C. Day, R. C. Nelson and C. J. Young are attorneys for the railroad while L. W. Matthew and W. C. Winslow represent the plaintiff. Selection of a jury is expected to begin this morning.

KIWANIS PROGRAM MOSTLY MUSICAL

Local Artists are Heard— Address Given by Mrs. W. E. Anderson

Practically the whole of the Kiwanis club luncheon hour Tuesday, was given over to music as a part of the music week program being carried out by all the clubs and civic organizations of Salem.

Miss Nellie Schwab, accompanied by Miss Mildred Taylor, sang two numbers, "My Name" and "Wake Up". Miss Schwab has a voice of exceptional quality, and her rendition was much appreciated. Little Miss Mildred Roberts, the 10-year-old daughter of Mr. and Mrs. J. J. Roberts, played two violin numbers, "La Serenade" by Herman and "La Cinquantaine" by Gallico. She plays remarkably well for a young girl. The DeMolay quartet, Harold Socolofsky, Theodore Paulus, Clifford Halsey and Robert Walker, with Dan Langenberg as accompanist, sang a negro spiritual, "I'll Be Ready When De Great Jay Comes."

Mrs. W. E. Anderson, chairman of the Music Week program, gave a brief talk on music, pronounced to be a poor public speaker though a good talker, but her address on music was remarkably well thought out and presented.

"There are a thousand kinds of sounds that can be musical," said the speaker. "Even the sound of her man splitting wood out in the back yard may be music to the housewife who wants that wood in her kitchen. There is no need of going to Europe for music or musicians any more. Many of the very best from Europe have already moved over to America to stay, and the local talent is matching the best importations."

"There are about 1500 people giving or receiving instruction in music in Salem. There is no bad music. Some kinds aren't quite as good as others, but it is all helpful—and the awful jazz is dying of strangulation. The serenaders of the university are in a lot better business than if they were in pool halls or roystering down town. Music is the one good thing that everybody can have and enjoy, only it costs money to prepare this music. No one ought to feel that a singer or instrumental performer should pay for a musical education, and then buy new music for every performance, and be glad to receive nothing but thanks."

The speaker announced much of the musical program for the rest of the week: the concert at Willamette university Wednesday night, the Girls' Glee club Thursday night, and the great Shrine program at the armory Friday night.
