Salem Man Dies in Portland
George O'Brien, a pioneer resident of Salem, died early yesterday morning at St. Vincent's hospital in Portland following an operation. He was 60 years old and until recently had lived on a farm in Polk county. He has been living for several months at 490 North Capitol street. The funeral will be held from St. Joseph's Catholic church, the exact time to be announced later.

Apartment Plans Preparing

Building Delayed
Work on the Northwest Canning plant on South Liberty street has been delayed by the non-arrival of steel for the concrete reinforcement. The forms are in for all the footings, the walls, and for the concrete floor, but until the arrival of the steel the concrete work itself will languish. A high mixing platform is being built on Liberty street, up which the trucks will back with all their gravel and cement

and from this mixing floor the mixed concrete will be run by gravity, making the delivery ideally fast. It will take about five days for the pouring of the job, once the steel is in place.

Answer Asks Dismissal
In an answer filed to the complaint of D. M. Drival in the circuit court yesterday afternoon, the defendant, H. D. the apparatus and equipment, and \$250 damages. Such was the substance of a complaint filed by the latter in the circuit court yesterday. According to the complaint the apparatus, equipment and furniture was sent to Portland from Nampa, Idaho, and then switched to Salem where it now lies on siding, the Southern Pacific company refusing to deliver the assignment to the plaintiff upon his request.
