NATIONAL ADVERTISING WILL HELP TO STABILIZE OUR GROWTH AND PROSPERITY

National advertising is a subject of vital importance to Salem and the Salem district.

Coupled with quality products, proper distribution and selling energy, it means the stabilizing of market demand over this country and throughout the wide world for what we raise and manufacture and pack and ship.

Immediate market demand; and it means the creation of a good will demand that in a measure gives control to our producers; makes for what amounts to a franchise; compels the cooperation of the dealers all down the line; not only for the crops of a season or a year, but throughout the years.

And it insures a sure and steady expansion. It has been said that advertising is the life blood of business. It is also the most powerful agent of industrial and community expansion and prosperity. California has proven this beyond peradventure, and Oregon is beginning to prove it.

It does not cost appreciably more in freight charges to reach the 100,000,000 people east of the Rockies than it does to reach the 12,000,000 on the western slope; it costs very much less to land a car of fruit in New York or Boston or Chicago than to send the same car to Denver.

This takes into consideration only rail freight charges. The development of shipping in large quantities by water makes the difference in favor of the eastern markets in many sections even more favorable to our producers and our manufacturers and shippers of local products.

And the freight rates to parts of Europe and the Orient on Salem products are lower than to many parts of the United States; and thus the wide world is our market, and it will pay to advertise and otherwise exploit what we have to sell in all lands, and to market the products of our soil as they are harvested or in manufactured form in every country; and we are already doing this. Scotland is one of the best markets for Oregon prunes. England has been taking large quantities of our prunes almost ever since we have produced prunes. The list is extending constantly.

With national and international advertising, Salem is no pent up Utica.

On the contrary, the world is her oyster. We will draw an increasing stream of money from wider and wider distances for the products of our soil—and it will be new money, and the resources instead of being exhausted will increase constantly; and this will come about with the aid of general advertising.

THE SANTIAM MINES

The time is very near for large developments in the Santiam mining region. There are a number of proven properties in that section; especially along the Little North Fork of the Santiam river.

But the one that is nearest to the things that must be done in order to bring about mining and milling on a large scale, yielding big profits, is the Lotz-Larsen group.

There has just come to this concern, as general manager of its mining operations, A. W. Constans, with many years of experience in developing and operating mining operations in Montana and western Canada. Mr. Constans did not have to come here. His services are in demand where he is best known, and at a high salary. His reputation is at stake. He could not afford to back a dud; to line up with a district without certain prospects of possible great developments. He knows how to get the ores out and to treat and market them. He is no dreamer.

And he has cast his fortunes with the Santiam district; come in on the basis of a working interest, and he expects to stay till a big paying property is developed.

This is one of the best signs of sure success, and that before long, that has ever come to the Santiam region. Mr. Constans says the gold and silver in the ores in the group he will work will pay for the mining—that the copper, the major portion, will be profit; "velvet" for the people who do the work and own the stock.

If Mr. Constans can be given the support he should have, and expects, Salem will before long wake up with a big mining camp at her front door, pouring annually increasing millions into her channels of trade.

A NEW MEANING

A new meaning was put into an old set of words this week when Mrs. Charles R. Gannaway of Medford and her recently adopted daughter, Zadi, appeared before the Salem Rotary club. Heretofore to most of us the words "Near East Relief" have meant just another collection of funds. We had heard that children were hungry, but we had taken it on faith.

Salem has never questioned the worthiness of the effort to save the children of the Near East for the professional and business life of the city have been enriched by members of the Armenian and Syrian races, but we've never seen thousands of scattered, hungry children.

This week we looked into the face of one of these winsome, beautiful children and we came under the spell of her attractiveness, as thousands of others have done. Three years ago it seemed that all the sorrows of the Near

East were gathered up into her little body.

Hereafter, when we hear the words, "Near East Relief," if we think of hungry children—and we will, we will think of thousands of children rescued by the self-sacrificing work of such women as Mrs. Charles R. Gannaway, who have counted not their own lives dear that health and strength might come into the pain-racked, disease-ridden bodies of thousands of children.

It is with a great mingling of emotions that one looks into the face of such a child as Zadi Gannaway. Indignation at the nations who have stood by and allowed a race which can produce one such child to be almost exterminated; regret that great as is America's work, she has not saved more of the children for lives of usefulness in the Near East; gratitude that we have done as much as we have, and probably best of all a determination to strengthen the hands of such folks as Mrs. Gannaway, as they march

their lives against our dollars in saving thousands of children from a fate worse than death, and to stand by them until the job is finished.

THE GRANTS PASS MEETING

The women who attended the meeting at Grants Pass under the supervision of Mrs. McComb and others from Oregon Agricultural college enjoyed an unusually interesting meeting, an account of which has appeared in the news columns of the Oregon Statesman. The title of the meeting was "The Homemakers' Institute," but it was more than that. It was a homemakers' institute where the women learned things that would help in their house work, but it was also a meeting where the women were encouraged to come out of their shells and take a part in the great activities of the world about them.

Farm women have been too much in retirement. They have devoted their efforts to a single home, whereas a mother should be a mother to a whole community and should cooperate with the other mothers in being a mother to the world.

We need our mothers and our women folks generally to be progressive and active. We want them to keep thoroughly up-to-date, and the things they can go best are the things around their neighborhood where they will not neglect their families but give a portion of their time to community service.

The meeting at Grants Pass was in a sense local, but that is all right. If we could have one in every county we would find every county responding splendidly for better things and enlarged activities for the women and a more considerate attitude toward them. We need the women in our community life; we need them to help direct community affairs, and we must equip them to do this work. Such courses as the one provided at Grants Pass help do this, and the women will go home with enlarged vision, a more set purpose and a better realization of their obligation towards their community life. The Oregon Statesman is very happy to see this movement take place.

ON THE RECORD

Milt Miller believes he has discovered something original when he says that McNary will be held to his record.

Of course he will be held to his record. Furthermore, Senator McNary is not going to dodge his record. The record he has made in the senate is one that will appeal to the people of Oregon. In the hundreds of votes cast Mr. Miller picks out one. The country generally is opposed to that vote, but that is a closed incident. It is one vote out of a thousand. Our people will not pick flaws in a record of statesmanship and service such as Senator McNary's friends can show.

We welcome the campaign to be centered on McNary's record. It means the republican party will be vindicated overwhelmingly. He has been an outstanding, aggressive senator and he has a national reputation. He is called into conference by the big men of the party and he is one of the leaders in shaping party policies.

Yes, Milton A. Miller can be easily accommodated if his wants are so simple that they will be supplied by McNary running on his record. He doesn't need to apply force, he just needs to gather up his person and get out of the way of the avalanche coming down the road to overwhelm him in November.

CONTROL OF THE SENATE

Senator Moses states that his particular part of the campaign is to help secure republican control of the senate. That means that the republican senators now running for election must be returned and several other seats regained. One of the vacancies is in Oregon. Oregon republicans will take care of that. There will be no change in this state. Senator Moses can devote his talents to organization in other states and we wish him all the success in the world, but he need not spend any time in Oregon where the situation is unclouded and the republican prospects the brightest ever.

It is highly important for the republicans to control the senate. To re-elect Coolidge and give him a democratic congress will mean blocking legislation for four years. If you are for Coolidge as a matter of civic righteousness it is up to you to vote for the republican nominees for both branches of congress. The country has learned to love Coolidge and it will not knowingly tie his hands, but every democrat elected to congress in either branch means another knot in the rope that is trying to bind him.

WILL LABOR RESPOND

Gompers is a democrat but he does not like to get run over. The radicals in his ranks started to

run over him but he jumped in the band wagon. Gompers in his subsequent statement certainly is not helping the independent movement. He would incur the opposition of the best element in the labor ranks, the element that believes in prohibition. His statement not only bluntly attacks the republican and the democratic parties and their candidates, but gratuitously goes out of the way to give affront to the prohibition forces of the nation. Its assertion that "the Volstead act is contrary to the desire of the majority of our citizens, as well as the spirit of the 18th amendment," and its demand "that the Volstead law be modified to permit the manufacture and sale of beer containing not more than 2.75 per cent alcohol," will be resented, or coldly accepted by thousands of members of organized labor who see and appreciate the benefits that have come to the wage earners through prohibition.

A host of families of wage earners cannot be brought to the view of Mr. Gompers and the executive committee, that the beer saloon should be restored—and that is what Mr. Gompers is aiming at.

ABOUT NARCOTICS

We notice the statement in the Eugene Guard that narcotics are hard to get. We hope this is true, but we wish they were harder to get in every place in Oregon.

The Salem authorities are fighting this evil but we must admit that it has assumed gigantic proportions in Salem and we understand all over the country. It is a fight that must be made to the finish, and we should rally around it as we rally around the enforcement of all good laws.

The narcotic habit claims its victims by the thousands, and now that liquor has been outlawed, many people turn to this which is almost as great an evil.

ENCOURAGE SCIENCE

You know we are too much given to magnifying unimportant things in life and too little to looking after the real things. We permit scientists who are making the most of our real advantages to go through the world unheralded while we permit the stage to exploit its actors to a nauseating degree.

Some of these days this is going to be reversed and science will come into its own.

The scientists themselves are to blame largely because they are poor advertisers. They do not give the public the results of their conclusions.

A GOOD IDEA

The mayor of Walla Walla has issued instructions that every city officer who fails to register for the election will be automatically discharged. This is not an attempt to coerce men into voting a certain way, but it is an attempt to insist upon all men participating in city government and to participate in government all along the line. It is a mighty fine idea and we wish the mayors of other cities would take it up in the interest of higher citizenship.

WITHDRAWAL ACCEPTED

INDIANAPOLIS, Ind., Aug. 6.—Withdrawal of John Zahnd of Indianapolis as the presidential nominee of the national independent party was formally accepted by the party's national executive committee at a meeting here tonight. Mr. Zahnd announced his withdrawal on July 23 in a statement in which he expressed his approval of the La Follette-Wheeler ticket.

STATE HEARS SETTLER PLEA

North Unit People Make Dramatic Appearance Before Commission

Settlers from the North Unit irrigation project of Jefferson county and their sympathizers, including a delegation from the Portland Chamber of Commerce, yesterday made, it is said, the most determined and drastic appeal ever directed to Oregon officials when about 100 men gathered in the executive offices and asked the state irrigation and drainage securities commission to certify bonds for the construction of the district and a guarantee of interest on the bonds for five years. United States Senator McNary and Representative N. J. Sinnott of the second Oregon district were present and gave their support to the district representatives.

Luper to Investigate
As a result of the appeal State Engineer Rhea Luper was directed by the commission to assemble in a committee "the best engineering brains in the state" and make an economic investigation of the project with reference to the ability of the settlers to make annual payments to meet the expenses of operation, maintenance, interest on state bonds and family expenses. The investigation will also cover soil conditions and a suggestion by former Governor Oswald West that the project be constructed in units, the first to cost about \$5,000,000 instead of the \$8,000,000 estimated for the entire project.

State Engineer Luper said that he has not decided whom he will name on the committee.

Time Indefinite
No time was fixed for Luper to report back to the commission.

The climax of the appeal yesterday came when former Governor West took the floor and declared that "more money has been sunk by servant girls in worthless stocks and bonds offered by Portland crooks than you have certified for irrigation projects in this state." This remark incidentally gave a hint of a report that will be due soon from West as chairman of a special committee appointed by the governor to investigate alleged sale of worthless securities in Oregon.

West called attention to his own experience while governor and to that of Governor Pierce in listening to the pleas of mothers and sisters for the lives of men sentenced to be hanged, and asserted that these appeals were insignificant compared with the appeals "of these hundreds of people of the North Unit project who are pleading for their hopes, their homes and their very lives."

End Near, Says West
"This is their last meeting," said West. "They may not know it, but it is. If they leave here without the aid of the state it is the end of the North Unit. Even if you grant this they are not all going to succeed. Some are going broke. But all development is built up on the wrecks of individuals."

The endorsement of the Portland Chamber of Commerce was presented by Whitney L. Boise, chairman of the land settlement committee, and Frank Andrews, president. Mr. Boise introduced all the Portland speakers and others outside the project, and Harry Gard of the North Unit project introduced the settlers. J. P. O'Brien and a representative of the Spokane, Portland & Seattle railway presented the endorsement of the railroads. Mr. Boise mentioned several Portland business leaders who sent their endorsements through him.

New Wealth Needed
Senator McNary called attention to the federal investigation that had found the project feasible and declared that the Oregon delegation in congress would take up irrigation as rapidly as possible. He declared that of 28 projects on which the government has appropriated \$141,000,000 only 4 per cent are delinquent.

"I know that this board is a trustee of the funds of the state," said Senator McNary. "and I know that the people of Oregon are heavily taxed and heavily bonded, but it is only by the creation of new wealth that the state can get rid of its heavy taxation and its bonded indebtedness."

Governor Pierce told Senator McNary that the commission is not against irrigation, the certification of irrigation bonds or the guarantee of interest, but declared that he would be compelled to go before the next legislature and ask for an appropriation of \$100,000 or \$200,000 to pay interest on irrigation bonds.

Federal Aid Lacking
Representative Sinnott, ranking member of the irrigation committee in the house of representatives, declared that the immediate future of the North Unit lies in state aid. It is probable that all federal aid in the next ten years will go to the Baker, the Warm Springs and the Owyhee projects. He

emphasized the point that if the commission finds that the North Unit settlers have correctly represented their ability to "pay out" and the possibilities of their land under wear it is the board's duty under the law to lend its aid. Numerous other speakers were heard.

All the Silver a Woman Wants

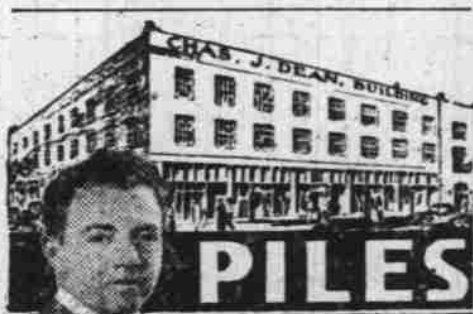
