also asserted that under the terms of the naval limitation treaty itself, the United States could not be on par with Great Britain in the matter of capital ships at least until 1932.

Action of the Washington arms conference was defended by Chairman Hale of the naval committee who declared the American representatives were advised by the leading naval experts and that in arriving at the ratio of 20 capital ships for Great Britain to 18 for the United States they took into consideration all factors, especially that the 18 American battle-ships were more powerful than an equal number in the British fleet.
