

ZBYSZKO WINS CHAMPIONSHIP TITLE FROM MUNN IN TWO STRAIGHT FALLS

AGED ATHLETE WINS HANDILY

'Terrible Pole,' 58 Years Old Gets First Fall in 8 Minutes

PHILADELPHIA, April 15.—Stanislaus Zbyszko of New York tonight regained the world's heavyweight wrestling title which he formerly held, by defeating Wayne "Big" Munn, Nebraska giant, in two straight falls.

The first fall came in 8 minutes 11 seconds, and the second in 4 minutes 53 seconds. In pinning Munn's shoulders to the mat the first time, Zbyszko used a forearm hold. The second time he employed a forearm and hammer.

Munn created a sensation when he won the title from Ed (Strangler) Lewis in Kansas City last January and his defeat by the veteran Zbyszko tonight was almost as big a surprise.

Zbyszko is 58 years old, weighs 210 pounds, and in height reaches only about to Munn's shoulders. The former Nebraska athlete weighs 260 pounds and is 6 feet 6 inches in height.

Zbyszko who several years ago lost the heavyweight title to Lew Lewis, demonstrated decisively that science in some instances is greater than strength. Munn tried repeatedly for his favorite crotch hold, but the veteran was too clever and squirmed out of his grasp. Munn also attempted a jiu jitsu hold but Zbyszko calmly broke away, leaving the big fellow standing with a look of surprise.

Officials of the state athletic commission said that Munn's manager claiming the wrestler was ill, had asked Zbyszko to permit his sparring partner to substitute for him after the intermission. Zbyszko refused. After the match club physicians examined Munn and announced he was suffering from acute tonsillitis, that he had a high fever and had fainted in his dressing room between the first and second falls.

Champion High-jumping Canine Is Quite Aristocratic in Appearance

"Pasha" Is Beautiful Russian Wolf Hound and Has Appeared on Orpheum Circuit With His Master; Visits in Salem

Ordinary dogs may, when on a credit. For some time he appeared on the Orpheum circuit, from which he was forced to withdraw because of injuries suffered when he fell over a hurdle in making a jump. At about this juncture in the conversation, "Pasha" decided that he had eaten all that he cared for, and with stern dignity, resumed his position of honor in the rear seat, and, with absolute indifference to the crowd around him, awaited the pleasure of his driver.

"Well, of all things, is this the best this town affords." "Pasha" has retired from active work, the undefeated champion of the world. His record high jump is 8 feet 8 inches, and was made something over a year ago. Although only 3 years old, he has a varied list of experiences to his credit.

BASEBALL OPENER AGAIN POSTPONED

A return match has been arranged between Robin Reed, welterweight champion of the Pacific coast and Johnnie Maurus of Oakland in the armory at Albany Friday night to decide the bone-wrestler to retain the title.

Read and Maurus recently went together at Albany for one of the classic bits of wrestling that local fans ever have been privileged to see. Reed wrestled the crown from Maurus in a fall with a double wrist lock.

So fast was the match, it is stated, that wrestling fans were unable to determine some of the holds used. The same kind of a return match is promised for the coming Friday evening.

Robin Reed attracted nationwide interest when he captured the World's Olympic wrestling title at Paris last year, and acclaimed the paramount of amateur wrestlers. After his return to the United States he entered the professional game and at present is wrestling instructor at the Oregon Agricultural college.

The last match at Albany was one of the best local fans have witnessed and the American Legion committee have secured larger quarters for the return match. It is expected that the crowds will be cared for at this time.

At the last match over 500 people watched the two human lightning bolts strike at each other for a solid hour and 40 minutes. So fast did Reed and Maurus exchange holds that the wisest of the fans could not keep track of them.

Reed was for the most part the aggressor, and from the indications he will take the initiative in Friday night's battle. Reed and Maurus are considered the only two men on the Pacific coast who are contenders for the welterweight title. Previous to their former match Reed was considered the only man worthy to contend for the title, and he demonstrated his skill.

Reed has only been in the professional class the past several months, having an amateur standing prior to his coaching contract with the Aggies.

A preliminary between Albany and Corvallis wrestlers will precede the main event.

Test in Bombing Is Very Satisfactory

Major General John Lejeune commandant of the marine corps and Rear Admiral William A. Moffett, chief of naval aviation, also were enthusiastic concerning the bombing tests, while no official tabulation of the bomb hits was made. It was conceded that one of the 10 dropped from 6000 feet landed within the target outline—620 feet long and 120 feet beam measurement—while the remaining nine hits were close.

At the 3,000 foot elevation the results appeared to be even more satisfactory to the official observers. Several bombs hit plainly within the buoy line of ship-shaped target and others straddled the target, the explosions raising the water in a way that submerged the buoys more than once. The bombs used for the tests were of the 120 pound type, loaded with a small charge of black powder.

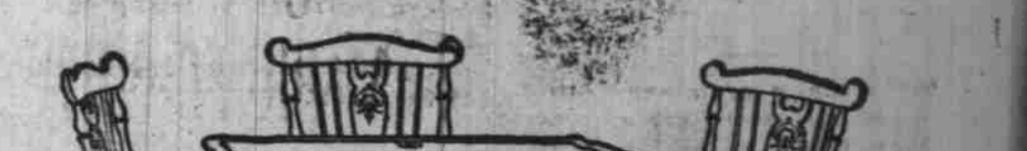
BRITISH TO TOUR AUSTRALIA
