

PUBLICATION SUMMONS

In the Circuit Court of the State of Oregon for the County of Marion. Equitable Savings & Loan Association, a corporation, Plaintiff, vs. Roscoe Farmer, Hazel Farmer, et al. Defendants.

To Roscoe Farmer, Hazel Farmer and Frances Allerton, defendants:

In the name of the State of Oregon: You are hereby required to appear and plead to the amended complaint filed against you in the above entitled suit on or before the date of the last day of publication of summons herein, to-wit: On or before the 16th day of April, 1926, and if you fail to appear and plead to said amended complaint within said time, for want thereof the plaintiff will apply to the court for the relief prayed for in its complaint, to-wit:

(a) For a judgment against the defendants, Roscoe Farmer and Hazel Farmer and each of them for the sum of one thousand dollars (\$1,000.00) with interest thereon from December 10, 1925, at the rate of eight per cent (8%) per annum.

(b) That the pretended transfer of the note and mortgage securing the same executed by defendants B. S. Burke and Maude May Burke in favor of defendants Roscoe Farmer and Hazel Farmer by said Roscoe Farmer and Hazel Farmer to defendant Frances Allerton be decreed to be null and void and of no force and effect, as to this plaintiff, and that the payments of the sums provided to be paid by defendants B. S. Burke and Maude May Burke to defendants Roscoe Farmer and Hazel Farmer in said note be paid to this plaintiff to be applied upon the judgment herein rendered against the defendants Roscoe Farmer and Hazel Farmer in favor of this plaintiff.

(c) That pending final determination of this suit the defendants, Roscoe Farmer and Hazel Farmer, be enjoined from transferring the note and mortgage executed by defendants B. S. Burke and Maude May Burke to said Roscoe Farmer and Hazel Farmer; the defendants B. S. Burke and Maude May Burke be enjoined from paying to the defendant Roscoe Farmer or Frances Allerton any monies due upon said note; the Bank of Oregon, Oregon, agent for the defendant United States National Bank of Oregon, Oregon, be enjoined from delivering said note and mortgage to Roscoe Farmer or Hazel Farmer or permitting the said note and mortgage from being withdrawn from said bank or the jurisdiction of this court.

(d) This summons is served upon you by publication in the Oregon Statesman (daily) for six successive and consecutive weeks pursuant to an order made and entered by the Honorable L. H. McMahan, judge of above entitled court, on the 4th day of March, 1926.
