WE HAVE NOT KEPT THE FAITH

"We here highly resolve that these dead shall not have died in vain."

That was the dedication to God of a whole nation on ground hallowed by the life blood of its champions—

The immortal words of Abraham Lincoln.

Memorial Day symbolizes not only the Christ who was crucified, but also the Christ who conquered death. The flowers for the dead should bear fruit in the living. After the soldier comes the statesman, but only once after a Gettysburg has come a Lincoln—

And behind the statesman stand the people. Today the statesman is unable to find the path to permanent peace. Lincoln found the path, and the American people still stumble—

We have not kept the faith.

Woodrow Wilson sent our armed hosts to France to fight a war to end war; to preserve the principles of democracy; to make certain that governments by, of and for the people should not perish from the earth—

And the result has been Lenin and Mussolini and a lot of lesser lights—now now it is being said that the World war was fought to make dictatorships safe.

We cannot say, as to the new mounds in our cemeteries, covered with flowers on yesterday's Memorial Day, in remembrance of the World war dead: "We here highly resolve that these dead shall not have died in vain." Yesterday the blossoms and the tears and the tenderest thoughts were for those who fell last fighting under the standard of democracy.

Our soldiers did their full and valiant part at Shiloh, at Vicksburg, at Chattanooga, in the Wilderness, on Lookout Mountain; and on Flanders field, at Chateau Thierry, in the Argonne forest—

And the American people have failed to keep their faith with their dead.

Our nation, founded to hold high the torch of civilization, dedicated to the principles of democracy; rededicated in the terrible cataclysm of the sixties; a third time set apart in the Spanish-American war, and a fourth time lifted to supreme heights of unselfish devotion before all the peoples of the earth, in the World war, still falters and hesitates—

Still fails to keep the faith with her soldier dead.

If our nation means anything, it means leadership for better things for the whole human race. We come short of our divinely appointed place as a people set apart when we fail to keep faith with our soldier dead—and the hopes, the ideals for which they gave their all become but withering wreaths and fading flowers in the cemeteries scattered around the earth from far Siberia to peaceful Salem.

HIS REWARD

(Portland Journal.)

Commissioner Teller is being supported by "the big port interests among which are the Dollar company," for chairman of the United States shipping board, says a dispatch from Washington.

Naturally, Mr. Teller is receiving that support for chairman of the board. "The big port interests" know their men when they see them. They often reward them for work well done—in behalf of the big port interests.

Mr. Teller has been a faithful servant to those interests. He has been one of the four men on the board to vote for the policy to "get rid of the ships at any price." He has been one of the four men on the board to vote for the Dollar deal, an irregular, mistaken and indefensible deal. He was one of the four to vote for a shipping monopoly on the Pacific. He has been one of the four to vote to abandon local interests in spite of the shipping act.

Had he voted the other way the Dollar deal would not have gone through, there would be no budding monopoly on the Pacific; there would be no policy of "get rid of the ships at any price," there would be no abandonment of local interests and the merchant marine, and there would have been no irregular and impossible deal.

And now, with the "big port interests" supporting him, he is probably to be made chairman of the shipping board.

Do the people of the northwest fully comprehend what is happening at Washington?

The above from the Portland Journal of last evening, is a sample of many bitter editorial articles in that paper—

And they are not getting anywhere. They are not constructive. Bert Haney, who was a member of the shipping board, and who is the Democratic candidate for United States senator from Oregon in the November election, is more or less an apologist for the policy of the shipping board in selling the ships, and he has no policy that is workable and constructive. Presumably, the Portland Journal will support Mr. Haney's candidacy, for it is a Democratic newspaper.

There is and can be only one satisfactory solution of the question of how to build up an adequate American merchant marine—

And that is through preferential duties on articles carried in American ships, and preferential port charges, the way the founders of our Republic provided for this thing, and succeeded in building up an American merchant marine, in the 61 years up to 1850, that was the wonder of the world and the pride of America.

Mr. Haney knows and says that, in some form, American merchant ships must be aided; must be given a preference over ships flying foreign flags, if there is to be an American merchant marine worthy of the name and adequate for the protection of our expanding trade in foreign ports—

But Mr. Haney flounders at this point.

He has no program that is constructive and that will do the work and stand the test. He talks of a direct subsidy. He hints at keeping American ships on the high seas as at present, at a great annual charge upon the federal treasury to make up their losses—

But the American people shy at a direct subsidy, as Mark Hanna found to his discomfort, and the present system of indirect subsidies cannot be made satisfactory. It is merely a makeshift.

If all the newspapers, and all the people who are hollering their heads off at the policies and practices of the United States shipping board, would get behind a measure for returning to the principles of the fathers of our Republic, the matter would be settled presently, and settled right. There is only one right way.

Bits For Breakfast

Wonderful weather—

For our Memorial day.

Now the labor shortage will grow more acute, with the cherries and loganberries coming in.

But the school children will join the workers in field and factory within a few days, and they will fill up the gap, or help greatly.

The beet sugar factories of California have been hard hit by the leafhopper pest. Three to four of the ten factories of that state were either crippled or put out of the running last year.

The Willamette valley is the place for beet sugar factories. We do not have the leafhopper west of the Cascades in this state. This pest completely knocked out the eastern Washington factories.

The six flax pulling machines of the state flax plant are being put in order, and it is to be presumed that the seven machines belonging to the growers will be ready for the harvest, the beginning of which is not very far away now.

A flax grower estimates that the crop this year will average two tons to the acre, and nearly all of it \$40 a ton flax. That will mean 4400 tons on the 2200 acres of land growing flax for the state. The biggest crop ever grown here.

COOLIDGE LAUDS DEAD IN ARLINGTON ADDRESS

vide those countries with certain political guarantees which our country does not require," and added:

"Besides this there is the world court, which can certainly be used for the determination of all justiable disputes."

As for war debts, Mr. Coolidge declared that in a spirit of helpfulness the United States had made "generous settlements" which preserved the principle of the payment of international debts and gave promise of being mutually beneficial to the trade relations of the nations involved.

The Arlington ceremonies were the central feature of the observance of the day in the capital city, with Senator Willis, of Ohio, who delivered an address after the chief executive also urging the cause of peace.

Leaving the amphitheatre the president, who was accompanied by Mrs. Coolidge, went to the grave of more than 2,000 unknown Union soldiers and deposited there a wreath while Mrs. Coolidge laid beside it a single red rose.

In the crowded amphitheatre were gathered thousands, including veterans of the Spanish and World wars as well as those of the Civil war in the familiar blue. Undaunted by showers that fell at intervals during the morning before the clouds parted at noon for a clear, warm day, the aged veterans assembled for a parade in which their younger comrades participated.

After traversing the streets of downtown Washington, they boarded trolley cars for Arlington and there placed wreaths on the grave of the Civil war unknown before attending the service at which the president spoke.

The tomb of the Unknown of the world war was also a converging point for thousands during the day, and in the morning Crown Prince Gustavus Adolphus of Sweden placed a wreath upon it.

As the ceremonies were proceeding in the amphitheatre, similar exercises were conducted at various cemeteries in and about Washington, while on the Potomac, the navy dead were honored by the Veterans of Foreign Wars from the Sylph, the yacht of the secretary of the navy. A huge anchor of poppies was lowered on the waters at this ceremony by Admiral E. W. Eberle, chief of naval operations.

Government activities were at a standstill for the holiday at both houses of congress and all departments closed.

APPEAL ARGUED IN HIGH COURT

who, unable to gain entrance, contented themselves by standing on chairs and tables. Hanging on with one hand, they tried to stir up a bit of air in the still court room with the other. Many others were turned away.

Scopes was not there. William Jennings Bryan, Sr., was not there. Tiring of playing the leading part in which he was cast at Dayton. Scopes has retired to the University of Chicago. Bryan, his last public utterance and argument he had prepared in this case, died soon after the trial had ended at Dayton.

One by one, counsel for Scopes, and for various liberal unions and leagues which have intervened in behalf of the convicted teacher, had their say before the court.

Dr. John R. Neal of Knoxville, chief of counsel, opened the case by presenting an outline of the contentions on which the appeal was based.

New York, speaking for the Unitarian League, followed with a declaration that "there are some Christians who do not believe the teaching of evolution," weakened the faith of the youth of the land.

Then came Arthur Garfield Hayes of New York, counsel for the American Civil Liberties union who argued that the law was unconstitutional because it was not compatible with the 14th amendment.

He went into the teaching of the various subjects relating to the sciences, and pleaded for the "protection of science," for the conservation of liberty of mind and of education.

Henry E. Colton of Nashville, counsel for the Tennessee academy of science, attacked the law from a technical angle.

Robert S. Keeler of Memphis concluded the day's argument for Scopes and Mr. Seay began his defense of the law. He commented upon the presence of Clarence Darrow of Chicago, and Mr. Hayes in the case, and read from the statements of the American Civil Liberties union and from a publication.

Weather-vane Still Serves After More Than 200 Years

ALBANY, N. Y.—(A.P.)—The old weather-vane brought to the Dutch settlement here in 1656, is still in active service. It is a jaunty Chanticleer of beaten brass, perched now on one of the two tall spires of the Madison Avenue Reformed church.

Except for three bullet holes, which tradition says were the results of potshots by the wondering and perhaps covetous Indians, the trim and well-proportioned cock has borne his centuries well. With head held high and tail feathers proudly poised, he swings with the winds and the storms, surveying from all points of the compass the city he has known since it was in swaddling clothes.

Revered as the oldest relic of Albany's early days, the weather-cock has been in its present position since the erection of the church in 1887. In that year it was recalled to duty after an eighty-one year vacation that began when the ancient church at the foot of State street, on which it had stood for 150 years, was demolished.
