BOARD FAVORS LABOR IN ARCHITECTS' PACT

(Continued from page 1.) "works" who should be agreeable to the board and will supervise the construction, being paid by the contractors.

All members of the board appeared satisfied with the V-shaped building shown in the tentative drawings, but this type of building will not be definitely decided on until the board looks at the scale model which the architects will present at the next regular meeting Tuesday.

The building in the tentative drawings is shaped like a V, opening to the north on Howard street at the intersection of Winter. Behind it will be a football field, built into a draw which runs across the tract. The building will have sloping roofs and the arms of the V will be 60 feet wide and 65 feet long on the interior side.

The chief attraction of the V-shape is the maximum of sunlight it will afford. The corridors, as shown in the drawings, will be 10 feet wide, with rows of lockers on each side, but the width is not considered sufficient, so the revised plans will probably call for wider corridors.

There will be 16 class rooms, eight on each of the first and second floors, with an auditorium on the first floor and a library above it. In the basement will be recreation rooms and toilets for boys and girls. The proposed future extensions will have 12 more class rooms and gymnasium space.

MARK S. SKIFF DEED SET ASIDE BY COURT

(Continued from page 1.) property in the county subject to execution and returned the same to the court with the certificate to that effect.

It was found at the time the note was given that Skiff was the owner of valuable business property in Salem, for which he and his wife subsequently had executed a deed to his son, Mark S. Skiff, Jr., as a gift. The deed was executed a few days before the note matured.

There was given to the bank as collateral to secure the note an automobile note, but it was found that the car covered therein was not worth possessing.

The Willamette Grocery company was a judgment creditor of the defendant, Mark S. Skiff, in the sum of \$614.96. The judgment was given in favor of the plaintiff and against Skiff on January 4, 1923. On April 5, 1923, plaintiff issued an execution on the judgment directed to the sheriff of Marion county, but the sheriff was unable to find any property subject to execution and returned the same nulla bona.

On June 20, 1922, while the above mentioned indebtedness and other large amounts of indebtedness of the defendant Mark S. Skiff existed, the defendant and his wife executed and placed on record a deed purporting to convey the real premises owned by the defendant to Mark S. Skiff, Jr. The deed was executed without consideration.

"It was found," read the opinion, "that the defendant, Mark S. Skiff, at the time of the execution of the deed in question, was heavily involved financially and that the execution of the deed would at least hinder and delay the plaintiff and the defendant bank in the collection of their demands against the defendant.

"The defendant Mark S. Skiff made the excuse for not paying the judgment referred to, that he was using his money in the sawmill business. He showed plainly an intent on his part to hinder and delay the payment of the demands asserted herein and his conduct conveying the real property was fraudulent as to such demands.

"It was claimed by the defendant Skiff that at the time of the conveyance in question, he was the owner of sufficient property to liquidate all of his indebtedness. The testimony showed that by execution of the conveyance in question the rights of the plaintiff bank were already extremely hazardous. It may have been true that under very suspicious circumstances, with success attending him on every hand, Mark S. Skiff would have in time, been able to meet his obligations. His creditors were, no doubt, hindered and delayed. There were badges of fraud shown in the testimony.

"There was a plain attempt on the part of Mark S. Skiff to cover up his property and prevent the plaintiff and defendant bank from collecting their demands.

"As against the plaintiff Willamette Grocery company and the defendant First State and Savings bank, the conveyance made by Mark S. Skiff and wife, to their son, Mark S. Skiff, Jr., of the property owned by Skiff at the

LORIS BAKER WINS PRAISE FOR WORK

Former Senator Player Listed as Able Pacific Coast Leaguer

Loris Baker, son of Mr. and Mrs. C. B. Baker, 425 North Liberty street, who has been signed as a shortstop with the San Francisco Seals, and who is recognized by sport writers as one of the ablest players in that position in the Pacific Coast league, is given a historical sketch in "Echoes From the Bushes," by Don McLeod, writing for the Oregonian.

"Loris Baker, after three years of baseball for Oregon Agricultural college, has signed with the San Francisco Seals. In his three college years Baker played every infield position but first. He started at second, switched to third and finished up as a shortstop. He was one of the leading Aggie hitters and was twice mentioned on all-coast teams. Baker played four years for Washington high before going to OAC. He was on the Washington high team in 1920 when it won the state championship. The Seals have signed him as a shortstop."

Baker, who is 21 years old, played several seasons with the Salem Senators and is well known here. He is a graduate of the

REV. NORRIS ASKS JURY TO INDICT FOR MURDER

(Continued from page 1.) who overheard Chipps' telephone conversation with Norris shortly before the shooting, and Baalam Shaw, church janitor who directed Chipps to Norris' office.

Sitting in the church office, almost on the spot where Chipps fell, Dr. Norris was by turns calm, vigorous, and sorrowful as he discussed various phases of the tragedy.

Tears came to his eyes when he said he was sorry that "this had to be," and he told briefly of his return to his family after the shooting.

He registered anger when he charged that there had been a conspiracy to kill him, and that he simply "beat them to it."

"Why this had to be visited upon me, I do not know," said Norris. "While I know that it could not be otherwise, I know also that there will be many dark waters ahead for me."

"I had to defend myself."

Dr. Norris said he had canceled all outside engagements for a year hence and expected to stay "in Fort Worth with my people, who have stood so loyally with me."

Dr. Norris' publication, "The Searchlight," will print this week an article giving the church's official version of the circumstances surrounding Chipps' death. The article is signed by J. J. Mickel, public relations director of the church. This article charges a conspiracy by members of another faith to attack Norris, principally because of a sermon he preached on July 11 on the subject "Six

members of the First Baptist church, fled by L. D. Haughey, Roman Catholic manager of Meacham Dry Goods company." This article charges that members of this faith visited Dr. Norris asking him to drop his attacks, that Chipps' visit was part of this same alleged "conspiracy," and that there are on the grand jury certain well known, long standing bitter enemies of Dr. Norris.
