Following on his defeat in the singles, yesterday, by Henri Cochet of France, Tilden, paired with Mrs. Mollie Mahory, American woman champion, was eliminated today from the mixed doubles of the Wimbledon tennis tournament.

The American team lost to Baron von Kehrling, of Hungary, and Miss Eileen Bennett, of England, 3-6, 6-1, 6-4.

Tilden's progress today was similar to that of yesterday. In the opening set he played a powerful game. His service was fast, his footwork was speedy, and his recoveries of some of Kehrling's deep drives were amazing. But, even as yesterday, Tilden seemed to tire, in the second set, he had less speed, his play was shaky and he made many errors.
