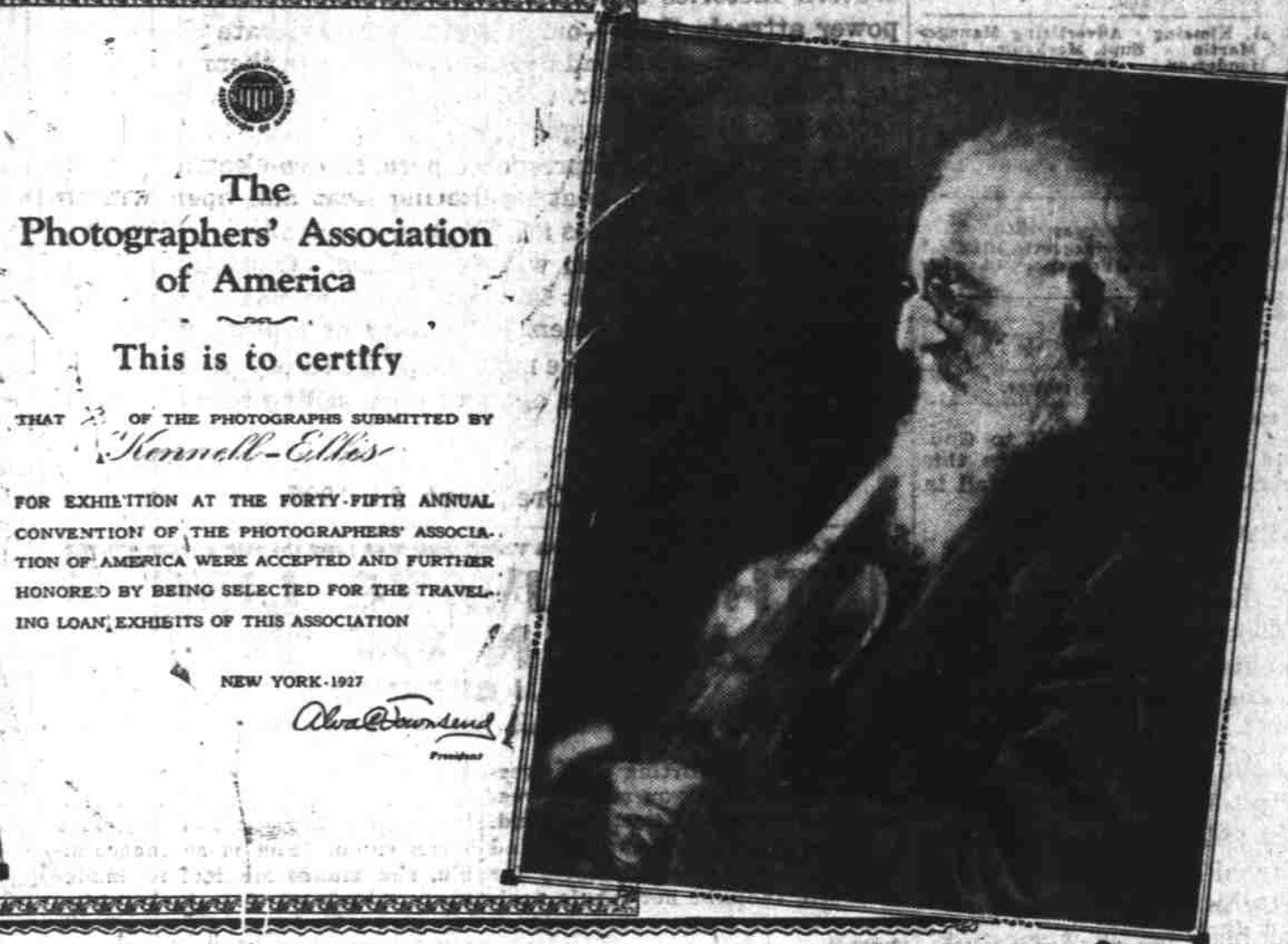

WASHINGTON, Sept. 23.—(AP)—Major Charles T. Harris, Jr., executive officer of the ordinance department, was advised about 9:30 p. m. tonight that a fire and explosion at the army depot at Curtis Bay, near Baltimore, had been brought under control.

Major Harris, who was in communication with the depot, said he was told a check of the personnel so far had disclosed none was injured, and that property damage had been slight.

The explosion was caused by heat from a fire which broke out on a shell loading platform, he said, and before it could be brought under control about 10 six inch Stokes mortar shells exploded.

The action of the land board was based on a previous recommendation of the attorney general that the state either compromise with the government with relation to ownership of the lands, or start suit in the courts to recover the lands under the swamp act.

Before a suit can be started against the government it will be necessary for congress to pass a law giving the state authority to sue. A resolution asking congress to pass such a law was adopted at the last session of the legislature and is now on file in Washington.

The attorney general probably will use the influence of his office to have this resolution acted upon at the next session of congress.

Investigators said that a number of witnesses had died during the past few years, and that if the state was to act the proceedings should not be delayed.

## STATE SEEKS TITLE

ATTORNEY GENERAL INSTRUCTED TO PROTEST

The state land board has instructed I. H. VanWinkle, attorney general, to protect the state's interests in the controversy with the federal government with relation to the ownership of approximately 24,000 acres of swamp lands in Lake county.

It was said that the government claims title to these lands under what was known as the Roosevelt bird refuge proclamation issued a number of years ago. The state claims ownership of the lands under the swamp act approved by congress on March 12, 1860.

The action of the land board was based on a previous recommendation of the attorney general that the state either compromise with the government with relation to ownership of the lands, or start suit in the courts to recover the lands under the swamp act.

Before a suit can be started against the government it will be necessary for congress to pass a law giving the state authority to sue. A resolution asking congress to pass such a law was adopted at the last session of the legislature and is now on file in Washington.

The attorney general probably will use the influence of his office to have this resolution acted upon at the next session of congress.

Investigators said that a number of witnesses had died during the past few years, and that if the state was to act the proceedings should not be delayed.

## HARRY ANSWERS CHARGE

Portland Broker Accused of Irregularities in Bond Sales

PORTLAND, Sept. 22.—(AP)—Dewitt L. Harry, former newspaper man and Portland bond broker, appeared in presiding Judge Tazewell's department of the circuit court here today in answer to a grand jury indictment charging him with larceny by bailies in connection with the sale of bonds and securities belonging to E. J. Pease, and with not making returns on the sale. Harry surrendered to the custody of the sheriff and in court submitted to a bail bond of \$3,000.

"You can say for me that all the transactions charged to me will be settled—absolutely," Harry said. "I have been checking the affairs of my office in an attempt to find out where things are at," he said.

Robert Mount, manager of the Better Business bureau here, said last week he believed the short-ages of the office would total \$15,000.
