ROY HARDING FILES SUIT FOR DIVORCE

Roy C. Harding, former professor of law at Willamette university and now on the legal staff of the state highway commission, Wednesday filed suit for divorce from Nadie E. Harding, daughter of "Bill" Strayer, prominent Baker attorney and veteran member of the Oregon state senate.

Mrs. Harding was a student at Willamette university for a number of years. She is now attending the University of Oregon. A considerable furor accompanied her marriage to Mr. Harding four years ago due to the prominence of both parties and the fact that the marriage was kept secret for several days after it took place. The divorce complaint filed in circuit court here Wednesday indicates that they were married in Portland on December 20, 1924.

The suit is based on alleged cruel and inhuman treatment. The plaintiff recites that he was ill with kidney stones between February and July of this year. "It further states that he was 'in need of almost constant care and attention. That during said time the defendant disregarded her marriage vows, spending the greater part of her time away from home attending shows, dances and other social functions; that during such time the defendant refused to care for or administer to the needs of the plaintiff. That on or about the 14th day of May, 1928, while plaintiff was so ill and confined to his home, but gaining back his health and strength, defendant told plaintiff she no longer cared for him and was going to leave him."

The complaint further recites that she did leave him and that as a consequence he suffered a nervous breakdown. No children are involved in the suit.
