Civic Organizations Represented in Preparation for Observance

Plans for the local observance of national thrift week from Tuesday, January 15, to Monday, January 22, were made Friday noon at a meeting of representatives of civic organizations of Salem.

The 10 major objectives of the week were brought before the committee by C. A. Kells, secretary of the Salem Y. M. C. A. and at Mr. Kells' suggestion, it was agreed that the aims of Thrift week be laid before as many citizens of the community as possible.

Schools, churches, service clubs and other community organizations will participate in the week's observance according to the tentative plans outlined by the committee which will bring its activities to a focus through daily newspaper publicity, before the week and during its observance.

BERLIN PAPERS SAY DEPRESSION GREAT

BERLIN, Jan. 4.—(AP)—Under heavy type captions the Berlin newspapers today published Washington dispatches to the effect that commercial attaché Fayette Allport, in his report to the department of commerce on the economic situation in Germany for the second semester of 1928, arrived at conclusions materially different from those made by S. Parker Gilbert agent-general for reparations.

The newspapers expressed great satisfaction at Mr. Allport's report, which they said was a salutary offset to Mr. Gilbert's "unjustifiable optimism."
