# GEORGE WASHINGTON LAUDED BY HAZLETT

The dominating moral sense of Washington as a man, rather than his contributions to the nation's existence and statesmanship as a war leader, as one of the framers of the constitution and as president, is responsible for the esteem in which the "father of his country" is now held. Representative J. H. Hazlett of Hood River declared in an address on the topic of Washington's birthday, Wednesday at the Salem Rotary club luncheon.

Washington was not one to keep his ear to the ground listening for public opinion; he believed in democracy but believed also in intelligent leadership as one of its requisites; and he would not compromise principle to the necessities of the moment. As a military strategist, he is gaining recognition, Mr. Hazlett said.

H. S. Gile, one of the charter members of the Salem Rotary club, spoke briefly on the history of Rotary, incident to its 24th birthday which occurs Saturday. He traced its growth from the first single group to its present membership of 140,000, including 3000 clubs in 46 countries.

A similar broadening in Rotary's principles has accompanied the growth in numbers, Mr. Gile said, pointing out that the original plan was simply friendship among selected business men, and business reciprocity.

# HOUSE BILLS MAKE NEW LOW RECORD

Only one new bill was introduced in the house Wednesday, a record so far for this session. It is numbered 535, and carries the name of Mrs. Dorothy McCullough of Multnomah. It amends section 3633, Oregon laws, relating to the depositing of funds with the state treasurer. It carries the provision that the funds should be deposited on receipt.

The fact that only one new bill came in is no indication that the house did not work, however. During the day it disposed of two heavy pieces of business, the new county classification bill as introduced by the special committee appointed to do this job and the famous Kuhl measure which would have combined the state budget act and the state purchasing act. With only a few dissenting county bill passed, but only a few voted "aye" on the Kuhl measure.

A total of 29 bills were passed, nine of them being house bills and 11 from the senate. The house calendar was cleared for the first time this week, although there is still plenty left to do.

# OCTOGENARIAN CLUB TO GROUP IS BELIEF

Perpetuation of the Octogenarian society begun here last week through the efforts of W. T. Rigdon may lead to the establishment of similar societies in other counties in Oregon, Mr. Rigdon believes.

"I have never heard of such a society before," he stated Wednesday, "but I believe that the idea is sound that old men should band together for mutual fellowship. It may be that in the future funds will be given our group and we will be able to provide help to men who need it."

At the present time the Octogenarian society has its membership extended to any man 79 years or older of good moral character.

# UNDER-GOVERNOR IS PENDING PROPOSAL

Does Oregon want a lieutenant-governor?  
This question is again to be decided, first by the legislature, and then if the legislature approves, by the people.  
A house joint resolution, calling for placing this proposition on the ballot is now in the act of being drawn, and is expected to be presented today or Friday. Just who is to sponsor this move has not as yet been revealed, nor has any sentiment crystallized either for or against it. It did not get through last session, however, and it may receive a like reception this year.  
The proposed act provides for a lieutenant governor who will act as president of the senate, but will have no vote except in case of a tie. It also provides that this officer shall take over the duties of the governor in case the governor, for any reason, leaves the chair vacant.

# Time is Ripe to Organize Clubs, Says Supervisor

The time has arrived for school children who wish to form livestock clubs, and especially pig projects, to begin organization, William W. Fox, rural school supervisor and director of boys' and girls' club work in the county said Wednesday. Poultry, rabbit and calf clubs should be organized immediately, and sheep projects should follow shortly, he said.  
All farm crop groups should select a project now and should prepare to organize. Up to this time few livestock clubs have been organized and no farm crop groups have been formed, although Mr. Fox expects a number to begin work with the arrival of the time when work may be outlined and planned.

# "State Not Broke and We Urges Upton Before Senate Should Quit Talking It"

Voting 16 to 14 for the resolution, the senate Wednesday backed Senator Jay Upton in his proposal that all ex-service men and women who have lived in the state for a period of ten years receive the benefits of the state bonus and loan act.  
"The state of Oregon is fifth among the states of the union with relation to per capita wealth," said Senator Upton. "The people of Oregon are not broke. The trouble is that a few politicians who are running for office go up and down the state preaching hard times in an effort to obtain the support of a foolish voter. Our bonds are adequately secured, and there is no valid reason for the propaganda of the state of Oregon is on the verge of bankruptcy."  
Senator Upton explained that under the resolution it would be possible to issue bonds up to four per cent of the assessed valuation of the state to care for the additional applicants who would qualify under the bonus and loan act. The issuance of these bonds is not limited to three per cent. Applicants under the provisions of the resolution would be compelled to pay four and one-half per cent for their loans instead of four per cent as under the present law.  
Senator Bailey, a member of the bonus and loan commission, said he was opposed to the principle involved in the resolution. He said the people of Oregon had taken care of the war veterans of this

state and that no additional bonds should be issued. "We have met our moral responsibilities in connection with taking care of the war veterans," said Senator Bailey. "and it is time to quit."  
Senator Bailey said the adoption of this resolution would make it necessary to increase the world war state aid bonds to \$43,000,000.  
Shade Trees Floored  
The senate indefinitely postponed a house bill introduced by Representative Settlemyer and others providing for the regulation, maintenance, planting and care of shade trees and authorizing the appointment of tree inspectors.  
"We already have too many inspectors in the state of Oregon," said Senator Marks. "and there is no need for this new official. While it is true that no salary is provided for tree inspectors in the proposed law, these officials would be before the next legislature asking for compensation. As I view the proposed law it would authorize

Senator Bennett also opposed the bill on the ground that there had been no request for its passage from Portland and Multnomah county.

**Drug Query Proposed**  
Investigation of the narcotic drug traffic in Oregon, Washington and California was proposed under a joint resolution by Senator Joe Dunne. The Oregon commission to conduct the investigation would be composed of three members. One member would be appointed by the president of the senate, another by the speaker of the house, and the third by the governor. The Oregon commission would confer with similar commissions in California and Washington.
