

NORMAL HAS CHAPEL LIST

Interesting List of Distinguished Speakers to Appear This Winter

MONMOUTH, October 4.—F. A. Cotton, a former president of the state teachers' college, La Crosse, Wis., and president for 15 years of the state teachers' college at Flagstaff, Ariz., was an interesting assembly speaker at the Oregon Normal school October 1, lecturing on topics of educational interest.

Additional speakers of national reputation are scheduled to appear at the Normal throughout the year as follows: October 8, Dr. Clyde Moore, rural supervisor of Cornell university, will lecture on rural topics. Miss Helen Heffernan, rural supervisor of the state system of California schools, will speak here October 11.

Lecture numbers are announced beginning October 30, when John Charles Thomas, internationally famous baritone, under management of the Metropolitan Musical Bureau of New York City, will sing in the normal auditorium at 8:15 p. m.

November 8, Dr. Wilfred Osmond, a distinguished naturalist and curator, in charge of the department of Zoology of the Field Museum of Chicago, and who, in 1926-27 was the leader of the Abyssinian expedition, will tell the absorbing story of his observations in mysterious Abyssinia, which he refers to as "the Tibet of Africa." Beautifully colored slides and motion pictures aid in visualizing this unusual travelogue.

The Moroni-Olsen players open here November 12, but have not yet announced their initial offering. They also play at the normal February 6 in "Makropoulos Secret."

Maurice Hindus, a leading authority on Russia and the Orient, who spent the summer of 1928 investigating conditions in China, Japan, Siberia and Russia; and the summer of 1929 in Russia and Siberia where he saw at first hand the clash with China, will lecture on his unusual experience February 12 at the normal.

COHEN RESIGNS AS PUBLICITY WRITER

So that he may accept one of two excellent opportunities offered him by large organizations in Portland and Los Angeles, Sam H. Cohen, who has been in charge of advertising and publicity for the Elsinore Theatre, yesterday tendered his resignation to Col. David E. Dow, who has taken charge of the Elsinore for the Fox West Coast organization.

Cohen is considered one of the youngest members of his profession in the country, being in his 23rd year, and having entered the show business at the age of 16. He formerly was employed by the West Coast theatres organization in Portland, where he had charge of all special exploitation and publicity.

He later left for Fresno, where he supervised the opening advertising campaign for the \$1,000,000 Pantages theatre, now known as the Warner Brothers theatre.

When he returned to Portland, George B. Guthrie, who recently disposed of his interests to the Fox organization, and who formerly operated the Elsinore, offered Cohen the post of publicity director. During his stay here he has won many friends and has done some very favorable work for that playhouse.

Who will succeed him at the Elsinore has not yet been announced. Cohen stated that he would leave for Portland as soon as he had completed his work with his present employers, and that he would probably announce his new connection within the next few days.

The crowds, and especially the women, took an especial interest in the ruddy, cheeked Scotch girl, who is the companion and official hostess of her father.

Marines Present Arms

For British Visitors

A marine guard, with arms at present, formed a lane through which the distinguished visitors walked. As Mr. MacDonald passed from the train shed, native Scotch pipers struck up a Scottish air and Mr. MacDonald acknowledged it with a broad smile.

At the reception room, the army band played "God Save the King" and the premier stood uncovered facing the musicians.

The photographers were given ten minutes before the party entered White House cars for the ride to the British embassy on Connecticut avenue.

Cavalry and Police

Precede Delegation

Motorcycle police, with sirens open, preceded the cavalcade and a troop of cavalry known as "the president's own" from Fort Myer formed the escort. The procession moved past the capitol and over historic Pennsylvania avenue beyond the White House to the recently widened thoroughfare upon which the embassy is located.

Crowds lined the streets as the cars moved, these being made up mostly of government workers who were trooping home after the day's labor. Overhead a squadron of nine airplanes flew back and forth across the avenue, the drone of their motors carrying loudly to the street despite their high altitude.

The prime minister and his daughter, with Sir Esme and Lady Howard, entered and began making ready for a official call upon the president and Mrs. Hoover at the White House.

RIOT AT PRISON TO BE PROBED

Danny Daniels, Ringleader, Suicides After Killing Five Companions

(Continued from Page 1.)

prison routine. This afternoon national guard tents were pitched in the prison yard within the walls. These tents will house a majority of the convicts in the prison until the cell houses can be rebuilt.

The riot, which snuffed itself out early this morning when the five ringleaders either ended their own lives or were shot to death by Danny Daniels, the moving spirit in the mutiny, who then took his own life, was the worst in the history of the Colorado penitentiary, and one of the bloodiest in the history of the nation.

Seven Guards and Five Convicts Dead

The death toll stood at 12—seven guards and five convicts—when nearly as many injured, some of whom may die.

One of the guards—Marvin Duncan—was under close guard in a hospital. He is believed to have lost his mind as the result of a night of terror spent in cell house number 2 in company with the mutinous convicts.

He saw two other unarmed guards shot to death and their bodies tossed out a window. He saw two others, bound hand and foot, shot to death against a wall, and permitted to lie where they fell, and he heard Danny Daniels, official executioner for the revolting convicts, send a message to the warden that Duncan would be the next to die.

The guards were killed in an effort by the convicts to compel prison authorities to comply with their demand for three automobiles and unmoistened freedom.

Only Few Ringleaders Participate in Riot

Following a preliminary investigation, Warden Crawford announced he is convinced only half a dozen desperate criminals actually participated in the riot. The remainder, he said, were compelled to accompany these men into the barricaded cellhouse on threat of death.

He also declared the convict's arsenal consisted of four revolvers and one rifle. The revolvers, he said, were smuggled into the prison, while the rifle was seized from a guard on watch in the crow's nest in the dining hall. Other guards inside the prison, he said, were unarmed.

He revealed that prison authorities were aware that arms had been smuggled into the prison, and had been conducting a vigorous search for them, even tearing up masonry at spots suspected of concealment.

Crawford also announced that none of the prisoners at the penitentiary had escaped in the confusion of the riot.
