



000 The board authorized the purchase of a new patrol boat for the state fish commission at a cost of \$11,000. The low bid for the boat was submitted by the Astoria Ma-

rine Construction company. Two other higher bids were received. The board adopted a resolution urging amendment of the present law extending aid to the state soldiers home at Roseburg would be increased to \$20 amonth. The resolution was presented to the board by Sam Starmer, commandant of the Soldiers' home. He said that 32 other states having soldiers' homes, had adopted similar resolutions.

Numerous changes in the new state office building aggregating a cost of approximately \$5,000 were authorized by the board. These ohanges in construction were were recommended by the state architect. The building is

now nearing completion and probably will be ready for occupancy in March. Virtually all of the larg er state departments now occupy ing space in the state house, will be transferred to the new structure. It is five stories high and of fire-proof construction.

A report from W. H. Baillie, superintendent of the State training school for boys, indicated that one of the four cottages at the institution had been closed temporariy, due to the liberal parole policy that has been practiced at the school for the past 18 months. A statistical report showed that only a few boys paroled from the school and placed in homes had

returned to the institution. A similar report was received from Mrs. Clara Patterson, superintendent of the state industial school for girls.




