## BURKE PARDON REQUEST MADE

### Ex-Kenton Banker's Release Sought Because Wife In Poor Health

A large number of letters and petitions have been received at the executive department here recently urging a pardon for J. V. Burke, ex-president of the Bank of Kenton, Portland, who is serving a term of seven years in the state penitentiary for willfully misappropriating the funds of the defunct institution.

This was announced by Governor Norblad here Tuesday. The governor said that several of the letters requesting leniency were written by physicians, who alleged that Mrs. Burke was in a precarious condition, and that her recovery was doubtful. Other letters were received from depositors who lost their funds through Burke's operations. The petitions were said to have been signed by many of the most prominent and influential citizens of Portland.

Governor Norblad said he had not made an investigation of the case, and had not received any recommendation for leniency from the officials who prosecuted Burke and the judge who presided at the trial and pronounced the sentence.

Burke was received at the penitentiary April 12, 1929. In addition to receiving a penitentiary sentence he was fined \$2500. Burke has been employed in the penitentiary department at the prison.

It was reported Tuesday that an effort also would be made to obtain a pardon for James P. Cooke, ex-president of the defunct brokerage house of Overbeck and Cooke in Portland. Cooke is serving a penitentiary term for misappropriating the funds of his clients.

Reports indicated that the applications for both of these pardons would be opposed.

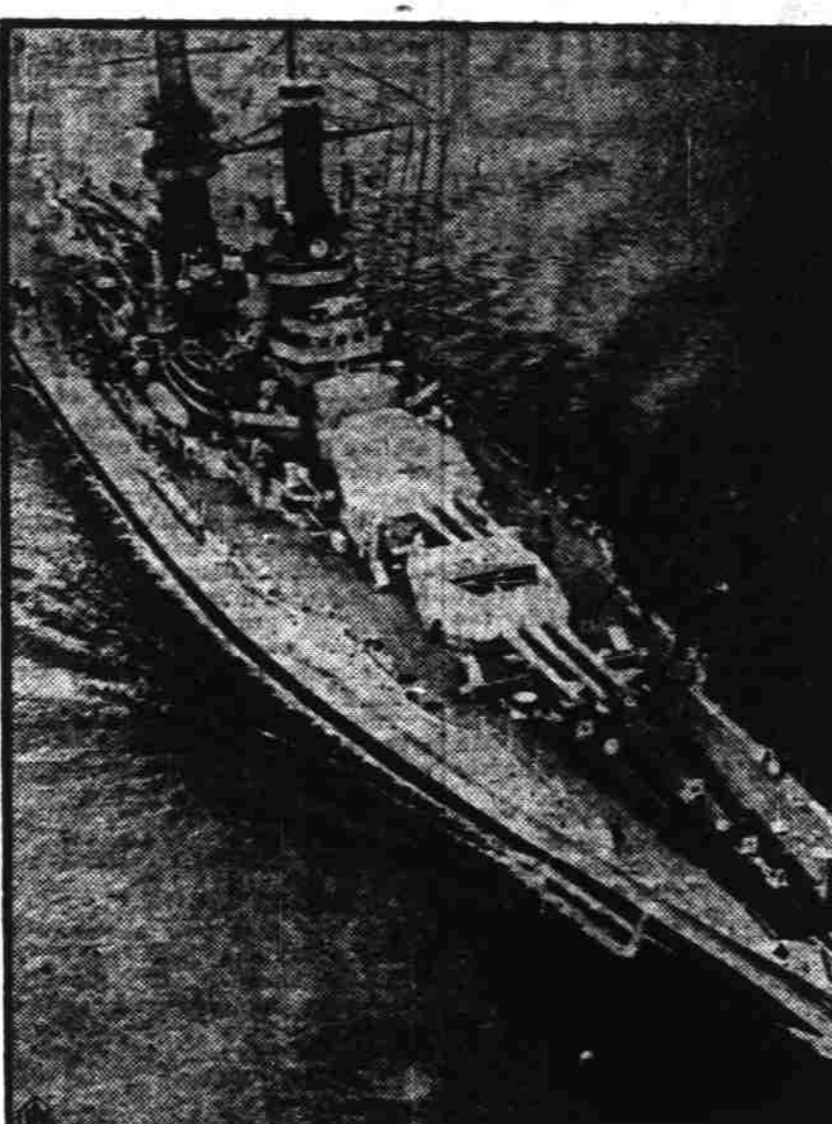

## GOVERNOR DENIES INTEREST IN CASE

### Has Not Been in Touch With Clifford, He Declares Replying to Rumor

Published statements that Governor Norblad had interested himself in Monday's meeting of the state game commission in Portland, and had talked over the long-distance telephone with Harold Clifford, deposed state game warden, were denied emphatically in a statement issued by the executive department here Tuesday.

"There was no truth in the statement that I placed a telephone call for Clifford from some unidentified point," Governor Norblad said. "I have not seen nor talked with Clifford for several weeks, and I had no knowledge of his removal from office until informed by an Oregonian correspondent late last night. I had presumed that he was conducting his office properly, but knew nothing of the evidence introduced at the hearing other than that which I read in the newspapers."

"I appointed four out of five of the present members of the state game commission, and they have had a free hand in their operations. There has been no dictation from the executive department as far as I am concerned."

Governor Norblad said he was not interested in who is to succeed Clifford and Ed Clark, deputy game warden, further than expressing a desire that the men are qualified to handle the work of the game department.
