Too Much Power to one man Savs Treasurer: Favors Lt. Governor Idea

Strong opposition to the paschine. sage of the state cabinet form of government through the referendum amendment to the constitution on the ballot today was expressed by State Treasurer Kay in an address given Monday before the chamber of commerce. Kay declared that the measure gave far too much power to one man.

"We establish our government SEPTEMBER FIGURE in its earliest form on the basis of divided assumption of responsibility and I think it dangerous to go too far from this principle." Kay asserted.

He said the Illinois cabinet form of government had worked well with Governor Lowden in command but pointed to the debacle under Governor Small as an indication of what may happen under a centralized government with an unscrupulous leader in charge.

Kay declared he favored the lieutenant - governor initiative measure. The principal reason he cited was the belief Kay holds that the lieutenant-governor, elected by the people and not responsible to the senate for his job, would exercise more impartiality and less log-rolling in the selection of committees.

Kay said the nominal salary of the lieutenant-governor overwas "just another position for in his own home. Mr. Dodson is the payroll". 


