## CRUELTY CHARGES COMING UP FRIDAY

Charges of cruelty preferred by Vernon Levey, 15, in connection with the conduct of the state training school for boys, have resulted in demands for the investigation of several other state institutions.

Most of the complaints filed with the board of control have to do with the food served at the institutions. Institutions of which investigations have been requested include the Oregon State hospital, state tuberculosis hospital and state home for the feeble minded.

Irvin Goodwin, Portland attorney, will appear before the board of control here Friday and present charges of alleged cruelty in connection with the conduct of the Oregon state penitentiary. Goodwin recently wrote a series of newspaper stories in Portland attacking the penitentiary and its management. Members of the board indicated that they placed little credence in the charges preferred by Goodwin.

It was said that a number of former inmates of the prison have volunteered to come to Salem and testify at the hearing.

## Tragic Death of Schaefer Noted By Friends Here

Salem people were grieved yesterday to hear of the death of George Edward Schaefer, suicide, at Yakima, Wash. Schaefer once lived in the district of Stayton and his brother, William Schaefer, is proprietor of the Maple confectionery here.

Edward Schaefer, separated two months ago from his wife and five children, went to Yakima to effect a reconciliation. He failed and Monday night in the yard of his father-in-law, he killed himself with a pistol. His oldest son, Harry, 19, struggled in vain with his father to prevent the shooting.

## REDUCED RATES TO GO IN EFFECT SOON

Marked reductions in railroad tariffs on commodities shipped to Willamette valley and southern Oregon points will be effective January 24, 1931. William P. Ellis, tariff attorney, announced here yesterday. The new schedule will be operative at that time under a 60-day extension granted the railroads from November 25, 1929, when the tariffs were scheduled to become effective.

Ellis represented a number of western Oregon cities in securing the reductions in the Fourth Section case. Under the provisions of the inter-state commerce act, railroads are not allowed to charge more than 100 per cent additional rates on inland commodities than on port-to-port goods meeting water competition.

Ellis was successful in showing that many interior rates were as high as 300 per cent more than those charged for port-to-port commodities in the Pacific coast district.

The new rates will give drastic reductions to inland cities, especially those in southern Oregon.
