

# NOTICE

In Compliance with the provisions of Chapter 115, General Laws of Oregon for 1931, and all subsequent amendments thereto, notice is hereby given that the County Court of Marion County, Oregon, will be in session at the Court House in the City of Salem, Oregon, in the Court Room thereof, on the 30th day of December, 1930, at the hour of 10 o'clock in the forenoon of said day, at which time and place opportunity for a full and complete discussion of the estimates of the amount of money proposed to be raised by taxation for the ensuing year will be given any taxpayer subject to such tax levy when made to be heard in favor of or against any proposed tax levies.

The following is an itemized estimate of Marion County's proposed tax levy for each department of County government, County Office or County Officer, each County improvement, the maintenance of each County building and institution, the salary of each County officer and employee, including those whose salary is fixed by statute.
