BECK TO SHOW HOW TO PRUNE

DALLAS, Jan. 1.—Next week for the fourth consecutive year, J. R. Beck, county agent, will conduct a series of pruning demonstrations. Pruning and cultivation are two essential requirements for prune orchards, and work already done has resulted in more uniform yields and larger sizes of prunes.

The first demonstration will be at the Andrew Verclat orchard, Tuesday, January 6, at 9 o'clock, located just west of the Schindler dance hall. At 1:30 in the afternoon a second demonstration will be in the Burt Oliver orchard just north and west of the Wallace pear orchard, about three miles from the Salem bridge.

The Verclat orchard is an old one which has been neglected and this will be the fourth year for demonstration work on it. The Oliver orchard is young, and this will be the second year.

Mr. Beck suggests that those planning to attend select the or-

chard that best suits their own condition and attend that demonstration.
