STORE MAN KILLS ONE OF HIS TRIO

MONTEREY, Cal., Feb. 21 (AP)—Robbed and beaten by three robbers Friday who entered his store on Seaside near here, Tom Spaulding, 66, grocery proprietor, shot and killed Manuel Martinez, 28, whom police said was leader of the trio. The other two escaped.

While the rifling of shelves continued, Spaulding said he sought shelter in a rear room and as the thieves started to go Martinez returned and allegedly threatened the grocer. Spaulding said he shot Martinez with another revolver he took from another robber in a rear room and Martinez died instantly.
