KNIGHT TELLS CREDIT EVILS

Often Based on Desire for Sales, not Ability to Pay, he Declares

"There is nothing more disastrous in the business world than the indiscriminate granting of credit," declared John L. Knight, president of the Knight Adjustment company, in his address before the Salem Retail Credit association at noon Wednesday.

Mr. Knight called attention to the fact that 85 to 90 per cent of the business done in the United States is done on credit of one kind or another. He said that credit has two phases, first the creditor's confidence in the prospective purchaser and second the creditor's desire to sell his goods. He lamented the fact that 85 per cent of the credit granted is granted on a basis of the desire to sell while only 15 per cent is on the basis of the estimate of the credit risk represented by the prospective purchaser.

Merchandise prices are forced up because of the loss incurred through the indiscriminate granting of credit; according to Mr. Knight. Merchants lose so much through bad accounts that they are forced to ask a higher price for their merchandise.

Mr. Knight characterized credit as a "wonderful convenience" but said that it should be limited to the essentials and not be made the foundation of good people, who through ignorance buy more than they are able to pay for.

Mr. Knight expressed regret that the bankruptcy law has been so abused. He said it was intended to aid those who, through no fault of their own, had been unfortunate but that it had become the tool of dishonest persons, because it is so abused.

WILL START WORK ON Y. M. C. A. CAMP

Work in clearing the land at the Salem Y. M. C. A. boys' camp in Tillamook will commence soon. A sum of \$50 was contributed to help the work along by an unnamed person, recently.

This work will start as a result of the letter received by the local association, Wednesday, to the effect that the 121-foot log span, bridging Short Beach creek to the Y. property, was completed a few days ago. This bridge is 50 feet above the creek bed and, according to those who have inspected the job, the work is highly satisfactory. It is built of logs cut on the ground and is wide enough and strong enough to bear an automobile or an ordinary sized truck.

An excellent road has been constructed to the property, according to the report. Two summer camps will be held at the resort this summer.

OUTLINE APPEAL IN CROSS-STATE CASE

Attorney General VanWinkle is now preparing necessary papers preparatory to appealing to the United States supreme court, on behalf of the Oregon public utility commissioner, the case involving construction of the cross-state railroad from a point near Crane to Creswell.

The original order of the interstate commerce commission directed the Oregon-Washington Railroad and Navigation company to construct the line. The railroad company subsequently appealed to the United States district court, with the result that the commission's order was reversed.

The interstate commerce commission already has filed formal notice of appeal in the case, and will be joined by both the Oregon public utilities commissioner and the Idaho public service commission.

The cross-state line was included in the original plan of the Oregon public service commission, looking to the extension of transportation facilities in Central and Eastern Oregon.

ASSAULT CHARGED TO EDGAR PERRIN

Charges of assaulting an officer were filed against Edgar S. Perrin, held in the county jail, yesterday. Perrin was taken into justice court and bail set at \$2,500. The matter will probably go to the grand jury, but whether it will be tried along with the charge of issuing a worthless check, on which he is now held is not known.

Perrin was the central figure in the attempted jail break Sunday evening, when he and Willard Crall sought freedom as Perrin sought to strike Deputy Sheriff Sam Burkhardt over the head with an improvised sap. Sheriff Oscar Bower and his gun were on hand to frustrate the attempt.
