

POLK COUNTY'S EVENTS BOOKED

School Superintendent Makes up Schedule for Remainder of Year

DALLAS, March 20.—The Polk county school superintendent has announced the schedule for county school activities for the remainder of the school year.

The county typing contest will be held at Monmouth April 11.

The declamatory contest for division two and four will be held at the West Salem community hall at 8:00 p. m., on May 5. These divisions include the third, fourth, seventh and eighth grades. Divisions one and three including the first, second, fifth and sixth grades will hold their declamatory contest in Dallas at the high school. This contest will be at 8 o'clock May 16.

The first half of this high school declamatory contest, including dramatic and humorous parts will be held at Falls City, May 21, at 8 o'clock. The last half of this contest will be held at Monmouth Normal school May 23. The second half includes the oratorical and extemporaneous speeches. The medals for the county track meet will be presented at this contest.

The high school track and field meet will be held at Monmouth Normal as usual. The meet will begin at 8:00 p. m., May 23. The grade school track and field meet will be held at Monmouth May 16.

The Polk county spelling contest will be held in the Dallas high auditorium at 8:00 p. m., April 25.

The eighth grade examinations for the entire county will be given May 14 and 15.

WOODBURN WILL HAVE OLEO FIRE

Sale to be Discontinued After Present Stock is Burned

WOODBURN, March 20.—Many matters of interest to the Woodburn community were brought up and discussed at the regular meeting of the Woodburn chamber of commerce which was held Wednesday night, this time in the Foresters' hall. The ladies of the Christian church cooked and served the banquet.

The matter of oleomargarine sales in Woodburn was brought up by Ronald E. Burnett, instructor in vocational agriculture at Woodburn high school, who requested that the chamber of commerce go on record as favoring the discontinuance of selling this product in Woodburn. This point brought up numerous discussions and it was finally voted that John Ramage has been authorized to buy up all the surplus oleomargarine of Woodburn merchants if they agree to discontinue selling the product. When the question of what would be done with the butter substitute after it was gathered up came up Ramage stated that he would burn it. Herbert S. Coleman of Champego spoke in favor of the movement and told how merchants of Mt. Angel, Hubbard, Silverton, Saint Paul and other towns would be willing to not sell any more oleomargarine if the Woodburn merchants would cooperate with them. Coleman is working for the interests of the Marion county Jersey Cattle club. Much discussion was again rampant after Mr. Coleman's statements and it was finally voted that the chamber go on record in favor of the discontinuance of the sale of oleo. George A. Landor stated that he would bring the matter before the Retail Merchants' association.

Arch to be Painted

The subject of painting the "Woodburn, World's Berry Center" sign across the Pacific highway at the end of Young street was brought up and bids were received from A. M. Reese and John Leek for painting the arch and doing the necessary lettering. After much parleying the members decided that the contract be awarded to John Leek, the lowest bidder. Leek's bid for doing the work was \$40. The money for the painting will be taken from the club's advertising fund.
