F. J. Gilbrath who is to manage the new organization already is said to have secured some orders for the plant. He is anxious to get the mill operating to lose as little sales continuity as possible. The plant has been shut down from January 1, 1931, to the present time. It employs from 40 to 50 people when operating with capacity production calling for many more workers.

It is expected if the pending deal is finished, that the plant will resume the making of yarn and will add coarse linen cloth to its output as soon as possible.

ORDER TO PREVENT PICKETING DENIED

Theatres in Portland Lose On Appeal; Business Loss is Claimed

The state supreme court, in an oral order, refused to grant a temporary injunction against picketing of Portland theaters pending disposal of an appeal for a permanent injunction. The case was appealed from Multnomah county.

The suits originally were filed by the Venetian theater, Granada theater, Moreland theater and the Dunn company against the Portland Moving Picture Machine Operators Union. The lower court held for the defendants. The theater owners alleged that the picketing had extended over a sufficient length of time, and that irreparable damage had resulted to their business.

The Dunn company recently disposed of its business, and its case was dismissed.

The court reversed a decree of Judge Kansler in a suit brought by Elmer E. Feig to recover damages of \$5000 from Horace E. Plummer, building inspector for the city of Portland. Feig, who is a building contractor, charged that Plummer revoked his license with the result that he was unable to complete a certain contract. The lower court held for the plaintiff.

The court held that the building inspector acted within his authority when he revoked the permit.

In another opinion the court affirmed the decree of Judge Tazewell in the matter of the estate of Ferdinand B. Pape, deceased. Chester H. Pape and Edward C. Pape, appellants, against the United States National bank, trustee and executor, and others.

Cases of the Union Dollar Service vs. the city of Portland, involving traffic ordinance and Fisk vs. Leth, were advanced on the docket. In the latter case Fisk alleged that the defendant was attempting to extend its electric lines into the territory occupied by a competing system.

Oregon Electric Seeks Right to Abandon Tracks

The Oregon Electric Railway company has requested permission of the interstate commerce commission to abandon 1.03 miles of its tracks between the Jefferson street depot and the North Bank station in the city of Portland. A copy of the petition was received at the office of the public utilities commissioner Tuesday.

The line which it is proposed to abandon extends from the intersection of Front with Salmon street west on Salmon to 10th, then north from 10th to Flinders.

LAUNCH INITIATIVE FOR PENSION LAW

Preliminary petition for initiating an old age pension law in Oregon was filed in the state department here Tuesday by Frank E. Davis and 19 other residents of Salem. The law provides that the completed petitions shall contain the signatures of 17,008 voters, and shall be filed with the secretary of state by July 1, 1932.

Persons eligible to receive the pension shall be 60 years or more of age, and have lived in the United States 15 years, state of Oregon 10 years and the county in which the application is filed one year. The pension shall not exceed \$1 per day.

A similar bill was introduced at the 1931 legislature but was defeated.
