

TURNER HOST TO S. S. MEET

Santiam District Convention Has Instructive Program

TURNER, April 14.—The Santiam district Sunday school convention, which meets quarterly, was entertained at the Methodist Episcopal church all day Sunday with good attendance. The theme for the program was "Go Ye."

After a song service and the lesson study period, a special was put on by the primary class of the Turner M. E. Sunday school, assisted by their teacher, Miss Olga Garner. Members of the Pleasant Point Sunday school who arranged on the platform. Before each familiar set of gospel verses were sung the Bible text which inspired the writing of the hymn was quoted, by each individual in turn. After congregational singing the morning session was given by Rev. E. J. Gillstrap of the Turner Christian church.

A bountiful lunch was served during the noon hour in a hall near the church, to 145 people. The afternoon song service was led by Kenneth Hickok. Prof. T. C. Mountain of Astoria conducted the devotional.

Expert Heard

The subject of "Week-day Church Schools" was well handled by Miss Mary Harling of Eugene, who has done field work in Lane county and thoroughly understands the undertaking both in the cities and the rural sections. She stated that "Oregon is one of the four states to be privileged to obtain these schools legally. A large percentage of the children

of the public schools are not connected with Sunday schools or churches.

"If there is to be peace between nations the children must be taught the love of Christ," Miss Harling urged that the convention take steps to organize for a church school for next year, as an accredited teacher can be found to take the work on a district platform.

After some discussion the president, John Mix, appointed Mrs. F. A. Boyington of Mehama as chairman and Rev. E. J. Gillstrap of Turner and Rev. W. Wright of Stanton as a committee to study the proposition, and to report to the next convention.

Special numbers from various schools were given, including a duet, "Sometime, Somewhere," by E. F. Wallace and Thornton McClellan of Amersville Bethel Sunday school, with Miss Helen McCullough at the piano. Five young girls of Mehama gave an Easter spring song. Visitors from Lyons were introduced.

Dr. Carl Doney of Willamette university gave the address of the afternoon on "The Promotion of the Church," stressing the thought that in this day our neighbors may live anywhere, even on the other side of the globe. A nation cannot have a civilization without the whole world doing its best. All must grow or starve. The task that is to be done, for ignorance and superstition must be overcome in our neighbors who have need of God.
