

SUSPECT STILL ELUDES POLICE

Mrs. Judd Sought by Army Of Detectives; Brother Repudiates Story

Anderson, saw blood seeping from the cracks of one trunk. He demanded that they be opened. Mrs. Judd said she did not have the keys, but would get them.

As she and McKinnell walked from the platform the agent jotted down the license number of the automobile. With this information police went to the home of Caroline Judd, sister of the doctor, and took the two men into custody.

Back at the station, the lids of the trunk were lifted and their contents revealed. In one was the body of Mrs. Le Roi. She had been shot in the head. In the other was the hacked and mutilated body of Miss Samuelson, whose death also had been caused by bullets in the head. In addition other parts of the younger woman's body were found.

Stories of Men Held Complicate Mystery

Questioned and requested by detectives, Judd and McKinnell told stories which further baffled authorities already desperate in the search for the woman and the hunt for a motive. Judd offered the possibility that her mind was "deranged."

McKinnell said his sister arrived in Los Angeles early Monday morning and called him from his class, telling him she had some trunks which she wanted him to take to the ocean and "throw them in deep water." He met her at the station. Insects hovering over the receptacles aroused his suspicions.

They left the station, presumably to get the keys, McKinnell said his sister confessed the crimes but offered no motive. He said she asked him for some money. He gave her \$5 and some small change which she took with her. She told him to stop the automobile and she jumped out, disappearing in the throng of street crowds at Sixth and Broadway, in the heart of the downtown district. That was the last he saw of her.

The story related by McKinnell changed again later in the day. He denied that he had implicated his sister in the crimes, saying "I have been misquoted" and that "she is innocent; she is not guilty of this."

WASHINGTON, Oct. 20.—(AP)—The tax-thirty government has decided to place a new decoration on the Capone mansion-hangout in Florida—a lien.

Only a flimsy bit of paper, perhaps, but with big words thereon signifying that back of it is the might of a government determined to force Capone to pay. This latest strategy in the drive to crush Capone and his ilk means simply that the government is out to attach every bit of his property it can find, from the estate in the south to the gaudiest necktie in the wardrobe he sports in the north.

The reason: to satisfy those back income taxes he stands convicted of evading. It may be asked why would liens be placed on tremendous amounts of property, when \$215,000 would satisfy the tax claim placed against the spendthrift gang director. The answer is that the amount already set as due may be increased up to \$1,000,000 or more.

Issel Is Fined \$500 for Shot At Indian Lad

THE DALLES, Ore., Oct. 20.—(AP)—Harry Isel, convicted last week on a charge of assault with a dangerous weapon, was fined \$500 in circuit court here Monday. Isel shot and wounded Levi Van Peit, 19, Umatilla Indian fisherman.

Isel was employed by M. T. Downes, commercial fisherman. The shooting followed a three-year quarrel between Downes and Indian fishermen over fishing rights.

Van Peit has filed suit for \$12,000 damages against Downes and Isel.

ROAD DISTRICT FOR MARION, LINN PLAN

The Linn and Marion county courts will form a joint road district for the obtaining of rights of way and meeting all costs connected thereto if preliminary legal papers submitted to the Marion court yesterday are ratified locally and at Albany.

Members of the court here explained the move as a means to permit Marion county to cooperate with the federal government in carrying the North Santiam road on from Whitewater creek, 31 miles to the junction with the South Santiam.

While the Linn county court will actually send out notices, conduct all suits for the obtaining of road rights and handle the costs of such action, the local county court agrees to reimburse Linn county for such work.

District Attorney Lewelling of Linn county prepared the preliminary papers which have been submitted to District Attorney John Carson for his consideration.

Members of the county court here said the Linn county court had shown an utter willingness to cooperate with Marion county in running the route of the North Santiam south from the north county line of Benton county.

TRUCK HAUL RATES FOR APPLES LOWER

Portland, Ore., Oct. 20 (AP)—Portland transportation interests were advised today by the consolidated freight lines that effective Thursday the truck rate for apples shipped from Yakima to Portland would be 25 cents a hundred pounds. The railroad rate for the same haul is 32 1/2 cents.

The Union Pacific system recently filed a tariff of 2 1/2 cents for apples from Yakima to Portland to become effective Nov. 1, but protests from Puget Sound caused the interstate commerce commission to suspend the rate until June, 1932, and called a hearing for Seattle October 23.

Seattle enjoys a rate of 2 1/2 cents on apples from Yakima.

The new truck rate, it was said, covers pick-up and delivery service.

DR. WARNER VISITS AT HEALTH CENTER

West More Prosperous Than East, she Says After Much Traveling

Dr. Estelle Ford Warner, formerly director of the Marion county health unit, paid a call in Salem Monday, visiting the health center in the interests of her present work which is connected with the bureau of public health, Washington, D. C.

Dr. Warner is at present at work on a survey of all the health centers of the United States. This necessitates visits to all the states before she has completed her survey. She is making her headquarters in Washington, D. C., but is able to spend very little time there at present.

At the conclusion of the survey a department is to be established in the bureau of mothers and children and Dr. Warner will have charge of establishing this.

Dr. Warner spoke of the much more prosperous appearance of the west in comparison with the east and central west. There are more people in the shops and apparently more business going on than is noticed in the other sections of the United States visited by Dr. Warner.

The south was spoken of by Dr. Warner as being apparently in much the worst condition economically of any place visited by her in her many miles of travel to date. One section of the south, in particular according to information expressed by a member of the agricultural department to Dr. Warner has lost so much moisture from the soil that it will require 25 normal years to regain the required amount to keep trees growing and fruit being produced.

Another way in which the west contrasts the east is in the presidential excitement. Presidential talk is an active part of Washington life right now according to the south, with President Hoover hardly as popular as Newton D. Baker, present secretary of war. In the west the eastern visitor notices a lack of interest in presidential nominations.

Dr. Warner will be a guest of her mother, Mrs. Ford in Portland, for a few days and then will return to Washington, D. C., after an absence of eight weeks.
