tained by Dr. B. F. Pound, \$870; Parent-Teachers, captained by Carl T. Pope, \$8660; Salem trades and labor council, \$1320.

At the executive committee meeting preceding the reporting session yesterday, it was decided to assemble the captains at a luncheon today noon at the Rose Cafe, 223 1/2 North Commercial street, to discuss the carrying on of the Work Promotion plan. The reporting meeting will be held as usual at 5 o'clock at the chamber of commerce.

Public Response Much Appreciated
The success of the plan thus far and factors which will assure its being put over the top were outlined by the executive committee, of which Paul B. Wallace is chairman. In the following statement:

"The response to the appeal for work pledges has been fine, many people pledging themselves to give more employment than the committee had reason to expect."

"One of the many examples of this is the pledge of a woman who, though already giving one day's pay a month out of a not too large salary, voluntarily pledged herself to do \$50 worth of needed repairs on her home, which had been planned for the fall, even if it were necessary to borrow the money to do so, in order to give needed employment to a carpenter whom she knew to be in distress."

"If this fine spirit were generally indulged in, the unemployment situation in Salem would be virtually solved, and a general business revival would be experienced. The committeemen are well aware of the hundreds of people in Salem who are anxious to do their part in making this campaign a success, but are unable to do so, either because of total lack of employment, or of only part-time employment. But they feel that every home in Salem, where the head of the family is steadily employed, be he renter or homeowner, should be able to find at least a day's work for some man or woman, if he is unable to afford some larger repair or building project."

Some Are Refusing To Accept Credit
Solicitors report that some people are refusing to sign a pledge, saying that they are doing considerable to assist in employment, or at least as much as they can, but do not want credit, and do not wish to make a definite pledge. To those people let us say that the American people work better in the mass or under organized cooperation."

"The single individual feels that whatever he might undertake would contribute an infinitesimal mite toward relief of general economic distress, and so long as he is uncertain whether a generalized appeal has persuaded his neighbors to activity, he is likely to procrastinate or find excuse for not doing."

"The meat of the Salem Work Promotion plan lies in the direct personal solicitation and the get-together purpose it contains; in the cooperative spirit it engenders and in its emphasis upon the theme that everybody's doing it."

"For that reason, when the solicitor approaches you, sign up for what work you expect to do, or for whatever work you had planned for spring, summer or fall, and have it done now, if you have already been solicited and find now that there is some item of work that you had overlooked, do not fail to call up the chamber of commerce to give this pledge, and help make the total of pledges."

Railway Labor Demands Exact Data on Roads

CHICAGO, Jan. 19—(AP)—Railway workers asked their employers today to explain why they thought a 10 per cent wage reduction necessary.

Labor, its spokesman at the rail reduction conference said, was unwilling to accept as arguments for wage reductions either the claim of "inequitable return" or comparisons of the cost of living.

The union delegation suggested detailed explanation of the needs of the railroads to meet their fixed charges and to maintain credit.

tion," the details of which he did not wish to reveal. "I consider this a personal matter between Mr. McCallister and me," said DeYoung. "The deal was satisfactory in all respects but I do not think it fair for me to comment more upon it. Out of fairness to Mr. McCallister I do not wish to reveal the securities which I tendered him for his note."

Testimony in the recently concluded trial of Jay Moltzner in Portland was given by the defendant to the effect that the Mortgage Investment company purchased McCallister's note to DeYoung through the Bank of California. Fitzwater, associated with Moltzner in business, denied to Barnett H. Goldstein, special prosecutor, that the note never went to the bank, saying Moltzner bought it direct from DeYoung.

Neither McCallister, DeYoung nor Moltzner has made court or public statements on the nature of the securities McCallister received for his note.

the cooperative group of producers although they have generally contracted to buy all "A" and "B" grades from this source. While "C" grade milk can be sold in Salem it must be plainly labeled "C" grade before being sold. In Portland grades lower than "B" cannot be sold. Heretofore there has been no public demand for "C" grade milk locally.

It is understood a movement is on foot to make "B" grade the minimum which can be sold here through action by the city council.

Distributors represented at the meeting last night were Spranger Dairy, Foshay Dairy, Maple Dairy Producers Milk company, Jersey Farm Dairy, O. K. Dairy, Pleasant Home Dairy, First Grove Farm, Meadow Grove Dairy, and Waldo Hills Dairy.

Plane Fails to Carry Supplies To Mining Camp

EUGENE, Ore., Jan. 19—(AP)—Snow and low-hanging clouds today frustrated an attempt to carry food by airplane to five men and one woman snowbound in a mining camp on Grouse mountain.

Through forest service telephones Fred Bartels, manager of the mine, last night informed his father, John Bartels of Cottage Grove, their food supply was running low. The senior Bartels engaged Herman Hobi, Eugene aviator, to carry provisions to the camp. Food was packed in bur-lap bags to be dropped from the plane; but Hobi was unable to locate the camp.

Another attempt may be made tomorrow.

Verdict Delayed On Impeachment Of Andy Mellon

WASHINGTON, Jan. 19—(AP)—A congressional jury of 23 today held in abeyance its verdict on what impeachment charges against Andrew W. Mellon warrant an investigation of the treasury secretary's official conduct.

Just after a cable from President Olaya of Colombia was read repeating Mellon's own denial of any conversations between the two on the Barco oil concession, the house judiciary committee concluded hearings on Representative Wright Fatma's resolution seeking the secretary's removal on an allegation of illegal business connections.

Jesuit Order in Spain Dissolved By Official Act

MADRID, Jan. 19—(AP)—It was learned today from a high government source that President Alcalá Zamora had signed a decree dissolving the Jesuit order and confiscating its property in the name of the state.

The informant said the decree, probably to be published in tomorrow's official gazette, also would prohibit the Jesuits from living together as chapters of their order.

SHIP WORKER KILLED

PORTLAND, Ore., Jan. 19—(AP)—Pete Jorgensen, 43, of Orchard, Wash., was struck by a boom and injured fatally while working on a steamship in the Portland harbor today. He died at a Portland hospital.

Cut in Federal Road Fund Will Not Halt Work

Reduction of \$25,000,000 in the federal road appropriations up to March 1, 1933, will in no way affect highway construction of the north Santiam highway, Roy A. Klein, state highway engineer, announced yesterday.

Klein declared that he did not believe the slash in the appropriation would affect materially any of the highway operations in Oregon.

The federal government has agreed to expend \$200,000 on the North Santiam highway, providing Marion county authorizes a similar amount.

Highway Fund is Aided, Turnover Of Gasoline Tax

Approximately \$250,000 was placed in the state highway fund Tuesday, as the result of the monthly transfer of collections from the gasoline tax, made by the secretary of state.

The month's gasoline revenue for the highway fund was \$284,524.78. While the receipts from motor vehicle license fees are allotted to the highway fund and the counties once every three months, the motor fuels tax is transferred at the end of each month.

Spaulding Not in Favor of Issuing Million in Bonds

Charles K. Spaulding, member of the state highway commission, does not favor issuance of \$1,000,000 in road bonds at this time, in order to provide funds for employment relief. Mr. Spaulding does not believe it will be necessary to issue bonds at the present time.

In the report of a highway meeting in yesterday's Statesman an error in reporting occurred in which it appeared that Spaulding did favor a bond issue.

Release Sought In Hawaii Case

HONOLULU, Jan. 19—(AP)—Habeas corpus proceedings to effect the release of Mrs. Granville Partoese and three navy men held for the murder of a suspected woman attacker were threatened today by their attorneys unless prosecution authorities present the case to the grand jury Thursday.

THREE DIVORCES GRANTED BY HILL

Three divorce decrees were granted in circuit court here yesterday by Judge Gale S. Hill.

Glean J. Garrison, married January 8, 1929, in Salem to Gladys D. Garrison, received a divorce on the claim that she left him July 5, 1931, and did not return. He said she was "no longer interested in him" and would be absent late in the morning.

A. E. Kiser obtained a decree from Roby M. Kiser to whom he was married in 1906 in Spring Valley, Minn. She is alleged to have abandoned him July, 1919.

Lucille Howard obtained a decree of divorce from John Howard and as a result he is unable to pay the money demanded in her suit since he earns only \$100 a month as an average and has been unemployed since last fall. His wife lived extravagantly while staying with him, Woods claims, and as a result he saved nothing and the \$300 house which he had acquired before marriage.

The defendant was adjudged in default by the court in the case of Pearl Albee against Harold DeRoy Albee.

SCOTT CASE HELD OVER UNTIL TODAY

Suit of Scott vs. the Mortgage and Loan company of Oregon was held over until Monday in circuit court here yesterday when counsel for the two litigants became involved in legal arguments for which more time was needed.

Judge L. H. McMahan dismissed the trial jury until Monday when hearing of the case will be resumed.

Judge Gale S. Hill heard numerous motions and demurs in his court yesterday and granted three divorces.

Today he will hear the case of the bank of Stayton against G. E. Berringer, et al. The bank claims that W. B. Berringer executed mortgages to G. E. Berringer, his brother, in a sum sufficient to weaken the security of the bank to the amount of \$1481.524.78. The bank says the mortgages were given without consideration and asks the court to adjudge them illegal.

At 1 p.m. in McManhan's court today, the former officers of the Empire Holding corporation are to be arraigned.
