'Buy-at-Home' Movement to Be Aided by Program and Free Dinner

A "kick-off" for the Buy Salem Made Bakery Products campaign, planned by all local bakers, will be held at the Labor temple tonight at 7:30 o'clock, and will be followed by a big six-course dinner. The event is open to all members and friends of organized labor, without charge.

A short program will be held, including brief speeches by representatives of the Bakers' International and the state Federation of Labor. Among speakers will be Frank Marshall, business agent for the Salem Trades and Labor council.

Following speeches, two boxing matches of four rounds each will be staged. Participating will be Phil Hayes vs. Tuffy Wing; and Buddy Ambrose vs. Young Morgan. About 200 and 300 persons are expected to attend the program and dinner.

WIDENING PROJECT VIEWED BY COURT

A slight curve on the Mt. Angel-Silverton highway will be widened if the county court can make a satisfactory deal with the owner of adjacent land for a piece of the corner, Frank Johnson, roadmaster, said yesterday.

Johnson and County Commissioners Jim Smith and Frank Porter visited the site after J. J. Kaber and Fred Schwab of Mt. Angel visited the court to call attention to the fact that several accidents had occurred at the curve.

While in this vicinity Thursday, the trio of county officials also inspected the bridge a mile north of Mt. Angel, and found that in an automobile accident there about a week ago the gas pipe railing was torn off one side and partly off the other side of the bridge, a concrete structure. This will be repaired immediately. A truck and an automobile met on the bridge, with damage to each and the bridge.

Occurrences and Gossip at the center of Oregon's state government

STATE holidays don't appear to mean much to Dr. R. E. Loe Steiner, of the state hospital. He reported at the capitol yesterday as usual to transact some business with officials, but found the offices locked. The state tax commission, however, was one of the few departments busy yesterday.

Newspaper men now have all three highway commissioners more or less off the reservation, and all that remains now is for the governor to appoint a new commission. But no confirmation has come from Meier, and it is doubted whether there will be that much of an upset. However it makes interesting reading.

Henry Hansen, budget director and political advisor of Governor Meier, who returned to Salem this week after traveling back east with the governor's party, said they couldn't hire him to live in the middle west or east. He said Oregon doesn't know what hard times are, nor does it know what depression means.

For instance, he said that beggars in New York, if you should ignore their request for money, would out and out insult you, whether it be a man or woman from whom they solicited. Political conditions in Chicago are worse, and there seems to be no question but that the city is ruled by gangsters.

After riding over Montana and North Dakota, Hansen wonders why they ever took that country away from the Indians, and adds that now they can't find an Indian to give it back to. He added further that people didn't know anything about Oregon, and when you settlement in Oregon. Since the state chamber of commerce stopped functioning Miller's office has been undertaking to do some of the work the chamber did formerly in the way of locating settlers on the lands in this state.

Miller's every effort was made to satisfy the demands of the prospective settler as to type of climate, proper location for type of farming desired, etc. The railroads, he said, are not just interested in a carload of freight, but in getting a successful and contented farmer on the land.

Copies of the pamphlet "Oregon," issued by the N. P., G. N., and S. P. & S. railways jointly were furnished those present, and the booklet was explained by Miller. Many pictures from this part of the state are included.

L. R. Schoettler and Roy Wasam outlined a sales promotion plan which Oregon City has developed.
