LANDMARK RAZED, WILL BE REPLACED

Old Clearwater Barn Is to Give Place to Modern Business Building

Another goodbye yesterday was being said to the era of the horse, with the tearing down of the old Clearwater barn, 554 Ferry street, which used to be a horse trading center. The two-story frame structure was built 22 years ago this month, according to E. B. Boatwright, who with S. B. Hall is tearing it down for the lumber.

Since horses were last kept in the building, a few years ago, it has been used variously, as storehouse and garage. The old Jorgensen building, adjacent to the barn, also is being razed.

Pratt and Rasmussen, plumbers, and Carl Armpriest, sheet metal contractor, who are joint owners of the Clearwater property, are considering erection there of a new building. They have not announced when construction will be started.

It is understood the new building will be two stories high and house both businesses. Plans and the type of construction will not be decided upon until the old building is out of the way.

The property adjoining to the east is owned by the Lemta Westcott estate of which Walter T. Stols is trustee. No new building is contemplated there.

JOB'S ARE PROVIDED FOR 165 LAST WEEK

Jobs were found for 165 men last week by the U. S.-Y. M. C. A. Employment bureau. Agent E. A. Kenney reported. Of this number, 82 were placed on the state highway and 48 on the county road emergency project. Eleven more were sent out to work during the previous week.

Applying for work were 68 men, 37 of them for state highway, and 21 women. Three women were placed, one as restaurant worker and two as houseworkers. Including the emergency road work, the office received 175 calls for help.

Men were placed as follows: farming 21, salesmen two, common labor two, mechanic one, wood cutter and painters one and 127 on the road jobs.

Women's applications for jobs were: farming two, waitress one, stenographer two, cook one, hotel work one, store clerk one, housework 13.

Registration for the emergency projects came within 10 of reaching the 1400 mark.

GAS ATTACK UPON FARM HOME TOLD

J. C. Murphy, living in the Springdale district of Polk county, appeared at the state police headquarters Saturday and told a strange story of an apparent attempt to gas his home and family.

Murphy said that following his retirement at 9 o'clock last night he heard peculiar noises and arose from his bed to investigate. On entering the living room of his home, Murphy said he was met with a barrage of gas, which forced him to his knees, and dulled his senses. He said he finally struggled to a window, and upon breaking the glass, regained his faculties.

Murphy then armed himself with a rifle, he said, and at that time saw a man run out of his garage. Murphy said he fired two shots at the fleeing man, but apparently neither of them took effect. Murphy and his wife then dressed hurriedly, and came to Salem where they told their story to the state police. The officers are investigating.

Murphy has lived in the Springdale district for a number of years, police said.

STRING TRIO GIVES PLEASING RECITAL

Miss Mary Schults, violinist, Michael Arenstein, cellist, and James Hutchinson, pianist, formed a trio which won for itself a warm place in the hearts of a large Salem audience Saturday night at the Salem Woman's clubhouse.

A program of distinction, colorful, artistic, and nicely balanced to show musicianship as well as melody, was presented with sincerity and brilliant interpretation and was received with warm commendation.

The presence of a piano with two string instruments is unusual but proved delightful with Mr. Hutchinson of Portland as the soloist. His personality was as infectious as the splendid molding of his notes.

Mr. Arenstein, first cellist with the Portland symphony, taught new beauties of the cello in his work Saturday night. His fingering was beautiful to observe, and brought sincerity of tone not often heard.

Miss Schults, Salem's own artist, was warmly received, and won new friends for her splendidly sustained work throughout the program. Particularly lovely was her work in Schubert's "Andante."

The brilliant concerto for violin and cello, "Allegro, Andante, and Vivace non troppo" movements was a triumph of the program. And unique and delightful was the violin and cello without accompaniment in Handel-Halverson, "Passacaglia". The rich, rare tones of the two instruments in this number appealed to the reviewer with particular strength.

Two encores, one "Swedish Dance" by Sandby, and Kreisler's "Old Refrain" were demanded before the audience would be satisfied.

The program of Saturday night emphasized once more the crying need of Salem for a fit place to give real music. The clubhouse is the best to be had, but it is neither large enough nor properly equipped for such presentations.
