

# Body of Lindbergh Baby Found Four Miles From Home

## DISCOVERY IS MADE BY PAIR

### Negro Sees Skeleton, State Police Called; Clothing Identification Basis

HOPEWELL, N. J., May 12.—(AP)—Formal statement that a body of a baby, identified through clothing and other means as the missing son of Colonel and Mrs. Charles A. Lindbergh, has been found was made late today at the Lindbergh estate.

The formal police statement: "We have to announce apparently the body of the Lindbergh baby was found at 3:15 p. m. William Allen, a negro, was riding from Mount Rose, N. J., to Hopewell with Orville Wilson on a truckload of timber. They stopped the truck near a woods. He, Allen, went into the woods on the Mount Rose Hill in Mount Rose, N. J. Going under the brush he lowered his head and as he raised a branch he saw a skeleton on the ground, and a person's foot.

Police are called. Body Identified "He called back to Mr. Wilson. Mr. Wilson ran into the woods, saw what it was and decided to go to Hopewell to get police. They notified Chief Wilt of the Hopewell police who notified these headquarters. Inspector Walsh of Jersey City, Sergeant Moffett of the Newark police, Lieutenant Keaton of the New Jersey state police and a number of other detectives immediately went to the scene.

"They reported finding the body of a child estimated to be between 1 1/2 and 2 years old in a bad state of decomposition, having blonde hair and wearing a flannel shirt and a pair of trousers. A flannel handkerchief was found near the body. "Not satisfied with this as identification the men sent back to Hopewell to the Lindbergh estate to get samples of the under-shirt the baby wore and of the flannel shirt the baby wore the night of the kidnaping (March 1). This flannel shirt had an embroidered collar on it. These articles were taken back to the scene and were compared with the clothing found on the body and were found to closely enough to afford an identification of the body as that of the Lindbergh baby."

amplify his brief statement about the two men, it was apparent he was acting in conjunction with county prosecuting authorities in an effort to assemble all pertinent information regarding the kidnaping which might be made the basis for grand jury action.

Colonel Schwarzkopf said the ransom note was not available and the prosecuting authorities had classed it as "important evidence" which would not be made public.

morgue of Coroner Swayze. She asserted she was "quite certain" the body was that of the Lindbergh baby, whom she had put to bed early on the evening of March 1, the night of the kidnaping.

She made the identification by "characteristic marks" on the body and by fragments of clothing.

Miss Gow's identification confirmed Dr. Charles H. Mitchell, county physician, in his definite conclusion the body was that of the Lindbergh baby.

"Several markings," Dr. Mitchell said, "on the baby's body checked up definitely with characteristic markings of the Lindbergh child. I don't think there is any doubt that this is the Lindbergh baby."

### F. Howard Zinser Candidate for republican nomination as county recorder

The statement of F. Howard Zinser, candidate for the republican nomination as county recorder, follows: "I was born in Illinois, coming to Oregon in 1894 and residing here most of the time since. My public and high school education was received in Oregon City, after which I attended Oregon State college. For four years I was employed in the horticultural department of the Oregon State hospital, the last two years in charge of the department. I spent one year in the army during the last war, receiving the rank of corporal in headquarters company of the 63rd Infantry. I spent four years in the full time professional service with the Boy Scouts of America in Salem and Spokane, and am now active as a volunteer worker. Have had three years of business experience as manager of a seed store.

"I have given consistent service to community activities as clerk of the Salem Heights school district and as president of the community club and have been in grade work and member of the American Legion and Woodmen of the World.

"I am a married man with a family of five children, and own my own home in the Salem Heights district.

"My platform is that I will conduct the affairs of the office of county recorder in a business like manner and Boy Scout down the expenditures to a minimum consistent with efficient service. I will at all times work in the interests of the taxpayers and will give personal attention to the duties of the office with courteous service to the public constantly.

### Carle Abrams Candidate for republican nomination as state representative

The statement of Carle Abrams, candidate for the state legislature, follows: "I was born six miles from Salem and grew up on the farm; lived in and near Salem all of my life; always owned and operated a farm or dairy ranch and realize the present burden and difficulties of the farmer; served three years as secretary and one year as president of the Oregon State Dairyman's Association; educated in Oregon schools and college; for 20 years a member of the Oregon National Guard, holding every office from private to colonel, and during that time directed the campaign to raise the funds and supervised the erection of the Salem armory; thus providing Salem's only auditorium; active member and former director of the chamber of commerce, Cherrians, for 20 years a director of the Salem Y. M. C. A.; served in the Oregon regiment in the Spanish war, Philippine insurrection, Mexican border Campaigns and World war, and now a colonel in the Organized Reserves.

"I was for 25 years co-publisher of The Oregon Statesman and The Pacific Homestead, serving successively as reporter, editor and business manager of The Statesman, and as editor and manager of the Pacific Homestead. "I am now engaged in the general insurance and finance business in the Masonic temple, Salem.

"State experience: Member of 1911 legislative session from Marion county. State Industrial Accident Commission, May, 1916, to April, 1917, resigning to enter military service. State Budget officer in 1924. Secretary of State Board of Control and state purchasing agent in 1924 to 1931. Inaugurated system of central purchasing for the state and organized present state purchasing department, effecting savings estimated at \$1,000,000 a year over old method.

"Platform: I favor legislation that will lift the tax burden from the farmer, home owner and laborer. I favor retraining in the cost of government, including lower salaries and legislative expenses. In the interest of economy, the state business should be concentrated at the capital. Less delays in court procedure. More respect for law by making the law more worthy of respect. Every man and woman is entitled to earn an honest living in exchange for honest work. Prosperity for all of the people. More pay rolls. No favoritism. If elected, I will face every issue squarely on its merits.

### Roy S. Melson Candidate for republican nomination as county commissioner

Roy S. Melson, candidate in the primaries for the republican nomination as county commissioner, was born in Heppner, Oregon, December 9, 1883. Prior to reaching his second birthday, his parents came to Marion county to settle, and Mr. Melson has resided here constantly since that time. Mr. Melson is a direct descendant on both his maternal and paternal sides of old pioneer families, his ancestors having settled in the Oregon country in the early 40's.

After receiving his education in Salem public schools, he graduated from the Willamette School of Law and later the Capital Business college. Mr. Melson was for ten years associated with the Capital National bank which is now known as the First National bank of Salem. He was also associate proprietor for a number of years of the Commercial Book store and the Atlas Book store, which he was instrumental in founding. He was also sole proprietor of the Peter Pan Confectionery store in this city.

All during his adult life, he has been actively interested in agricultural pursuits, having owned considerable farming property in Marion county, and he at present owns and operates a 35-acre place located in North Salem. Mr. Melson's abilities as a farmer are well illustrated by the fact that he at one time operated a 3000-acre ranch.

He was a member of the Salem city council during the years 1918 and 1919, and has always been active in civic enterprises.

Mr. Melson is pledged to the actual reduction in taxes by efficiency and economy, and his friends well know that this is no idle gesture on his part.

If elected, the residents of Marion county can be sure of two things, Melson says: First, that his training and experience have fitted him for the office of county commissioner second, that the affairs of the county will be handled in an efficient, economical and businesslike manner.

later, declared as preface to an address on northwest "products and resources at the Fraternis club meeting at The Spa.

"It is perfectly ridiculous that last year Oregon spent only \$25,000 to advertise our country. What we have got to do now is quit thinking just Oregon. The whole northwest should band together. Why not bring people here to do things—to play, at least. There is no place more beautiful. I have had many people tell me that."

"It is pathetic that Senator McNary had to ask our lumber bill to coal and oil. There was not enough interest in congress in an industry that employs thousands of people in the northwest to get it across. We have 150,000 acres of fruit in Oregon and if it wasn't for California's going out and hustling markets for the fruit, we'd starve as riding horses."

Mrs. Smith enumerated Oregon products which have some recognition nationally: the Douglas fir, Jantzen bathing suits, Pendleton blankets and rodeo hats. "The roundup advertises Oregon more than anything else. They have us pictured as riding horses."

With the Legion convention, Olympic games and international Rotary convention coming to the coast this summer, the Pacific coast should unite to interest people in the country, she asserted.

"There are over 20,000 members of the Women's Greater Oregon association and 1700 in Marion county. That is what we are working for."

"We should get away from 'Oregon products' and say 'western products.'" Mrs. Smith, Salem chapter of the organization, concluded.

## Large Damages Sought of Mill City Physician

Seventy-five thousand dollar damages are sought by Lucy Dawes through her guardian ad litem, Joe Dawes, in a suit filed in circuit court Thursday against William W. Allen, Mill City physician. Damages of \$50,000 are asked for specific injuries. \$25,000 additional is asked for general damages.

The plaintiff claims that the physician was out of town December 4, 1931, when her baby was born. His failure to attend her and the physical difficulties later encountered, caused a temporary derangement of her mental faculties, Mrs. Dawes alleged through her guardian. Finally it became necessary that she be sterile for the remainder of her life and the failure of her duly employed physician, Dr. Allen, to attend her, brought this on, the plaintiff contends.

## Mary L. Fulkerson Candidate for republican nomination for county school supt.

Mary L. Fulkerson was born in Minnesota. She has lived in Salem for 24 years. She has served continuously in the office of county superintendent of schools since 1918. She first was rural supervisor of schools and September 1, 1920, was appointed county superintendent when Superintendent Smith resigned. She was elected the following November and has twice been reelected. She believes in progress in education and yet enforces economy in her office and in schools throughout the county. Despite a rapid growth of population in the county, expenses of the county school superintendent's office have been cut \$2000 since 1920. Prior to her incumbency as school superintendent, Mrs. Fulkerson was for many years a teacher of the primary grades. She resides on a 15-acre farm near Salem.

Declaring they are "hustling along with Hulet" in his campaign to defeat W. C. Hawley for the republican nomination for congress, I. A. Snider, chairman, and Captain Leon M. Erickson, secretary of the Railroad Brotherhood Legislative league of Oregon, were in Salem Thursday on a tour that will take them into every section of the first congressional district before the primary elections a week from today.

The Brotherhoods, through their national and state legislative representatives, have officially endorsed the Hulet candidacy, and they declare they expect to put him over.

## Importance of Salem as Trading Center is Shown In Government's Report

Salem position as commercial center of Marion county and its importance in the general economic and industrial scheme of western Oregon are given particular attention in the United States commerce department's new report "Commercial Survey of the Pacific Northwest" made public Thursday, according to Frank Messenger, manager of the Portland district office of the bureau of foreign and domestic commerce.

The "Commercial Survey of the Pacific Northwest" is one of a series of regional studies made by the commerce department for the purpose of providing business men with basic information as to the wealth resources and marketing possibilities of the principal economic areas of the United States.

The largest retail center of the state outside of Portland, Salem commands a considerable amount of the trade of the upper Willamette valley, the government report shows.

The city's rapid population growth, amounting to 42.6 per cent from 1920 to 1929, is noted as an important element in Salem's economic development.

Salem, it is further pointed out, has one of the most diversified trading areas of the Pacific northwest. In addition to its income from lumbering, dairying, poultry raising, fruit production, hop and flax raising, and industries such as canning, paper mills and meat packing, the capital pay roll of over \$1,750,000 is shown to add appreciably to the city's income.

Retail sales as revealed by the national census of distribution totaled approximately \$18,000,000 in Salem in 1929, and nearly \$25,000,000 in Marion county. Particular outstanding among the retail groups of Salem, according to the survey, was the business in the automotive group. The sales of \$4,776,000 in automotive lines represented 26.6 per cent of the total retail trade. This proportion is considerably larger than that of many cities of similar size in the Pacific northwest, it is declared.

The "Commercial Survey of the Pacific Northwest" paints a broad picture of the economic life of the great area embracing the states of Washington, Oregon, northern and southwestern Idaho, and western Montana. The study portrays the wealth and importance of the entire section as a market for a wide range of the manufactured goods and other products of all sections of the country.

The people of the Pacific northwest, the government report points out, buy and sell in every market of the United States. Their relations in export and import trade extend to practically every country in the world.

Agriculture, lumbering and manufacturing alone, according to the survey, are found to add more than \$1,000,000,000 potential buying power to the pockets of Pacific northwest residents annually.

With 2.5 per cent of the total population of the country, it is shown, the Pacific northwest cuts over 25 per cent of all the timber, mines 15 per cent of the copper, produces nearly 25 per cent of the land and about 15 per cent of the zinc. Its wheat farms grow one-eighth of the country's entire crop, and its orchards more than 35 per cent of the commercial apple crop and 28 per cent of the pear. On the northwest ranges 15 per cent of all the wool is produced, while the coast fishing industry accounts for about 5 per cent of the annual American catch of fish.

News that her grandchild, Charles A. Lindbergh Jr., had been found dead, reached her shortly after she left Cass Technical high school where she has taught her chemistry classes stoically during the months of uncertainty since the kidnaping.

She refused to meet anyone outside her household. Her brother Charles L. Land, told all callers at the Grospe Pointe Park home that Mrs. Lindbergh had "nothing to say."

An airplane company called to place a plane at her disposal for a flight to Hopewell. The offer was declined.

She was believed to be at her home tonight. Any plans she might have for going east were shrouded in secrecy.

## Brown is Given 90 Days in Jail

Ninety days in the county jail and a fine of \$250 was handed out to George E. Brown when he pleaded guilty to driving while intoxicated when he appeared before Justice of the Peace Hayden Thursday afternoon.
