

CONSOLIDATION FIGHT IS EYED

Proponents and Objectors

Grande becoming junior colleges. Bitter rivalry between the university and state college has led to pernicious political activity and to extensive duplication was an assertion of MacPherson's, and this would be eliminated under consolidation, he claimed. He criticized the radio programs at the college and said the departments of journalism at the two schools were used for propaganda purposes, and referred to the editorial association as having been corrupted by the state university.

Damage to Eugene Values Stressed

Tugman for the Eugene and university interests severely condemned the initiative. He declared it would reduce property valuations in Eugene \$3,500,000 and wipe out almost entirely the \$1,000,000 investment in fraternity and sorority houses.

"Is the plan of the state board of higher education so faulty that it should be scrapped?" Tugman queried. "This board has worked for three years and approximately \$900,000 has been saved. The plan of the board calls for unification of the higher educational system under one administration. This plan has received the support of both the recent federal educational survey and reports of President Kerr of Oregon State college."

Tugman charged that it would be necessary to move approximately 2500 students from Eugene to Corvallis under the consolidation plan. "Our information discloses," Tugman continued, "that housing facilities in Corvallis are not sufficient to take care of this influx of students. He also said that such a plan would result in an unwelcome and shocking condition on the Corvallis campus."

"The consolidation proposal, if approved, would not only play havoc with the tax structure of the state and counties," Tugman continued, "but would destroy overnight 70 per cent of the value of the state university plant. Many educators who have bought homes in Eugene also would suffer financial loss."

Head of Taxpayer League Is Heard

Henry Zorn, president of the Marion county taxpayers league, was asked what action the league would take in case the ballot title prepared by the attorney general was held invalid. He declared that in such an emergency the petitions would again be circulated. When asked who was paying the cost of circulating the petitions and otherwise financing the campaign for the consolidation bill, Zorn replied that he could not answer. He later declared that the cost of printing the petitions was borne by the Marion county taxpayers league.

Zorn then read a lengthy prepared statement, in which he alleged that financial loss to Eugene because of the consolidation program would not be as large as had been reported in the press. B. O. Powell of Monmouth discussed the importance of the state normal schools, and stressed the reasons why they should be located in a small town.

Senator Wheeler of Lane county charged that the consolidation bill was hatched up suddenly and had not been given mature consideration.

Today the supreme court will hear arguments on the suit attacking the ballot title in which Dr. C. W. Keene of Silverton is plaintiff. An early decision is anticipated.

ties doing the processing at cost. Further conferences will be needed before the plan may be put into effect; and perhaps reorganization of the charity program effected.

Mr. Purvine, through his Community Service work of the past winter, is well acquainted with the need for foodstuffs and with their sources. He has directed the obtaining and storing of large quantities of fruits, vegetables and meats later dispensed through the charitable agencies.

Four-Point Plan Is Advanced Here

The plan, as outlined, is four-fold:

First is to guard, through local congressional efforts, that federal appropriation measures for municipal loans are passed by congress on such terms that they will be available to Salem.

Second, if the appropriation measures are made law, the city to borrow funds sufficient for purchase or construction of a water distributing system and of the gravity pipe line from the Santiam river.

Third, strenuous effort to be made toward expediting court decision as to validity of the water bonds.

Fourth, mobilization of volunteer workers and cannery equipment to save ordinarily wasted foodstuffs for the coming winter.

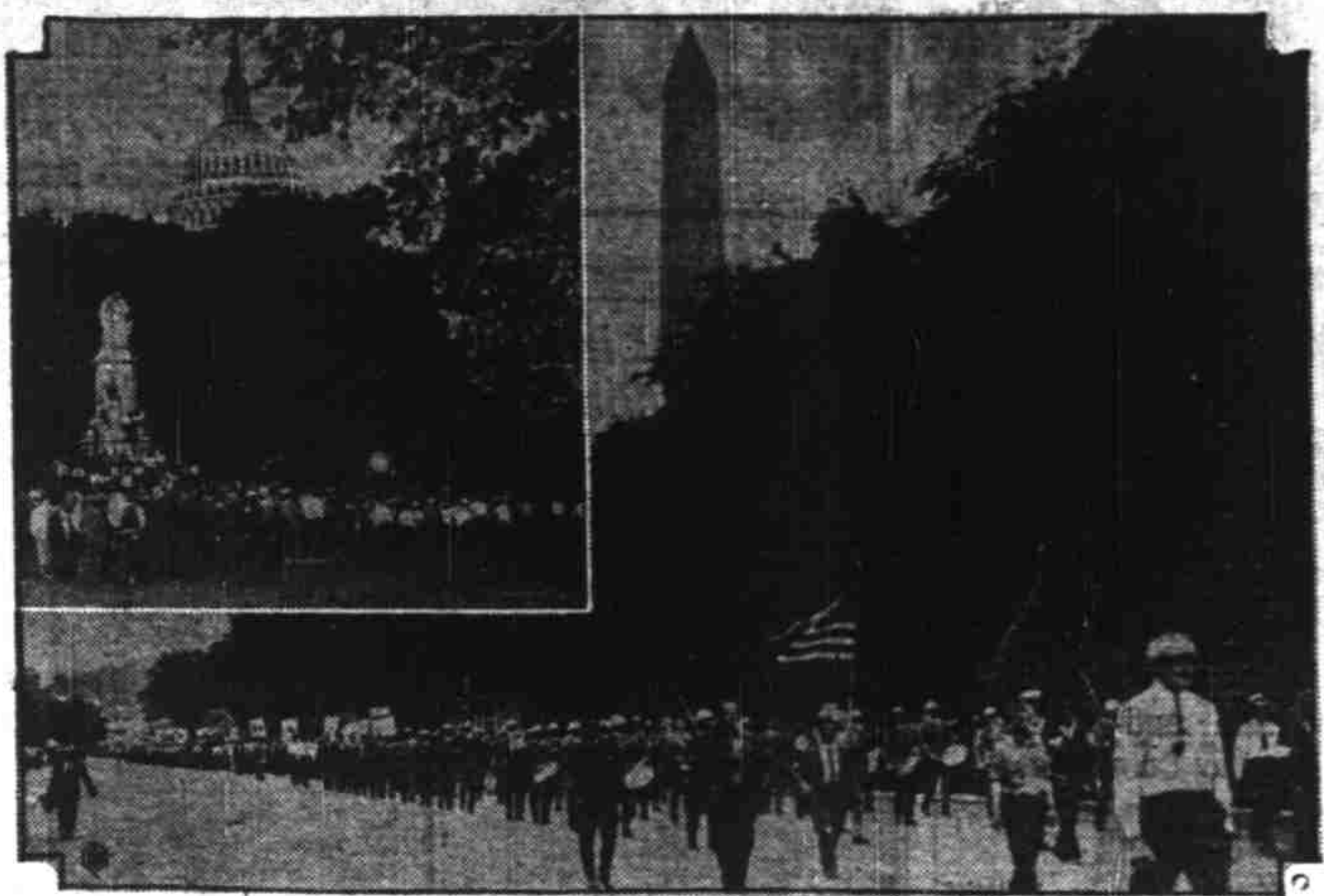

PETER JENSEN DIES AT POLK RESIDENCE

MONMOUTH, June 13.—Peter Jensen, 66, died Sunday morning at the family home here after several months of illness.

He was born May 10, 1866 at Skodburg, Denmark, and came to the United States at the age of 21, first settling at Fresno, Cal. Later he went to Emporia, Kan., and engaged in wholesale produce business. There he was married to Miss Mary Louise Perrier in 1898. Eight years ago they went to California, and in the past year they established their home in Monmouth.

The family had just returned from a visit with relatives in California when Mr. Jensen's death occurred. Surviving are the widow and four children: Mrs. O. C. Christensen and Miss Frances Jensen, Monmouth; C. J. Jensen, Portland; and Mrs. K. F. Wilson, Visalia, Cal.; a sister, Mrs. Marie Christensen, Denmark; and two brothers, T. Jensen, Emporia, Kan.; and C. Jensen, Redlands, Cal.; also four grandchildren.

The remains will be shipped June 14 to Emporia by the Keeney funeral home of Independence.

GASTON MEANS IS DECLARED GUILTY

Two Counts of Larceny are Proven in Lindbergh Ransom Hoax Case

WASHINGTON, June 13.—(AP)—Gaston B. Means was convicted tonight of larceny of \$104,000 from Mrs. Evelyn Walsh McLean in a fantastic plan to recover the kidnapped Lindbergh baby.

Two hours after it received the case in District of Columbia supreme court, the jury of 11 men and one woman returned verdicts of guilty on two counts of larceny of the \$100,000 ransom money and of \$4,000 expense money.

Verdict of not guilty on two counts of embezzlement of the same sums were returned.

Justice James M. Proctor remanded the former department of justice agent and ex-convict to custody after T. Morris Wampler, defense counsel, made a plea that Means be freed under \$50,000 bond, the same amount on which he had been at liberty during the trial.

Failing to get favorable action on this plea, Wampler and his associates, J. William Tomlinson, said they would try for a writ of habeas corpus from some other justice.

The maximum penalties possible on each of the larceny counts is ten years imprisonment, and, or \$1,000 fine.

Claim of Miles In Estate Case Is Disallowed

Claim of Ladd and Bush Trust company as guardian of the estate of B. J. Miles in connection with settlement of the estate of Donald W. Miles is disallowed in a decree handed down yesterday by County Judge J. C. Siegmund.

Myrtle Miles, the trust company as guardian and others filed objections and several hearings have been held on final account of James G. Heltszel as administrator of the Donald W. Miles estate. Claim of Annabelle C. Miles for \$1672.35 was disallowed, as was also claim of Margaret Miles Knight, with exception of an item of \$280 for board and room.
