PLANS MADE FOR SPAN AT MEHAMA

Profile maps were received from the bridge department of the state highway commission Wednesday for the construction of the Mehama-Lyons bridge.

The work is to be divided into two shifts of six hours each per day. Linn county is to remove the old wooden truss and build one pier before work is started by the contractor. He is supposed to notify the Linn county court seven days before he starts construction so as to inform the public. The contractor will have 45 days to complete the work, being forced to pay a penalty of \$25 a day after that time.

HEALTH WORK HERE WILL BE APPRAISED

With the arrival of Dr. W. F. Walker of the Commonwealth fund, New York City, appraisal of 1931 health work in Marion county has been started.

The appraisal will be completed around the end of next week. Under a rating of 1900 for meeting of all standards of the American Public Health association, Marion county in 1930 received a score of 846. Soon after the county health unit was instituted the county rating was only 202. Dr. Walker has made the appraisals here for the past seven years.

The appraisal includes all health activities, reports and conditions in the county, as well as just the work of the county health department.
