CHEMEKETANS PLAN TRIP UP COLUMBIA

Interest in the Chemeketa's boat trip up the Columbia river to Cascade Locks next Sunday assumed larger proportions yesterday. Forty-six persons were signed up for the trip last night, three times as many as Saturday.

The hiking club has chartered the steamer Undine of the Mid-Columbia Navigation company for the trip. A crowd of around 100 passengers is looked for. Both members and friends of the club may go.

Leaving the Senator hotel at 4:45 o'clock Sunday morning, the party will drive to Portland in time to embark at the Supple dock, foot of Belmont street on the east side, at 6:30. Light lunch will be available on the boat. As far as known, the only stops will be at the Bonneville hatchery and at Cascade locks. The return will be late Sunday evening.

Thursday afternoon at 5 o'clock is the closing date for registration, which may be made at the Senator hotel. Expenses for the trip are \$1 for transportation to Portland and \$1.50 for the boat fare.

This is the first trip of its kind ever attempted by the Chemeketa. W. I. McCloud, leader, and Gladys Miller, chairman of the local walks committee, are making the arrangements.

FAIRHOPE SYSTEM TO BE EXPLAINED

Innovations in educational methods as practiced at the School of Organic Education at Fairhope, Ala., will be the subject of a public lecture to be given by Mrs. Marietta Johnson, director of that institution, at the Y. M. C. A. tonight. The lecture is sponsored by the Lincoln, McKinley and Leslie parent-teacher association.

Mrs. Johnson is nationally recognized as an educator and her methods are incorporated in textbooks outlining teaching procedure and theory. Her main idea is that the school should be adapted to the normal growth of the child. Pupils are kept in their own age groups, automatically passed into high school at the age of 14 and sent on to college at 18.

With six children as pupils and a little cottage for a school house, Mrs. Johnson started her unusual institution at Fairhope in 1907. The school now has a 10-acre campus, nine buildings, representing schools from kindergarten to college, a teacher training group and an enrollment of 200 pupils.

During the summer course, Mrs. Johnson is instructing a branch of Oregon Normal school, Monmouth.

Under the Dome...

Occurrences and Gossip at the center of Oregon's state government

THE broadcast of the national republican convention last night brought to listeners the hottest session of the convention so far, and the press and radio gave a fine picture of the consideration of the platform, particularly the prohibition plank. And the two-hour debate was a real one.

The convention often reminded one of the prize fight, with everything, including boos, noise, cheers, yells, whistles, in fact everything but the bell. Even the constabulary was called in to restore order, and there were several pertinent remarks made from the stand in an endeavor to restore order.

The boos came during the reading of the 18th amendment phase of the platform, the majority report against re submission, and again during the talk by James R. Garfield in support of this majority report. Speakers were frequently denied opportunity to continue for many minutes.

During the parade for re submission when Senator Bingham read the minority report, no mention was made of Oregon. The delegation did not join the parade. The announcer said the parade showed many signs of beer—no beer, he added, but just "signs of beer." The show was really a good one and overshadowed the nomination phase.

The nominating part of the convention will not set the world on fire. Provision against such fire even carried to the extent of chemically treating the bunting decorations, so there would not even be a chance for fire from this source. But the debate on prohibition was another matter.

Remarks like "those who do not wish to hear the truth, close their ears to it," and "unless the visitors permit the speakers for the prohibition plank to continue the galleries will be cleared," caused an uproar just short of a riot. Subtle remarks about courtesy of visitors however brought the greatest move toward quiet.

It looked like the galleries particularly were packed with wets and those who favor re submission, but it would appear a better method would be to conform to pleas of quiet and courtesy than to drown the words of the opposition with "boos" and noise. The

speakers for and against the majority report were big men and were interesting speakers.

But let's get back to Salem and the state capital. Oregon has a little fight of its own on its hands, and that fight is attracting as much attention as the prohibition plank fight at the republican rally. Yesterday the opponents of the so-called consolidation move won the first round.

The supreme court returned a verdict favoring the appeal from the ballot title for the proposed initiative measure, and submitted a new title. The word "consolidation" was taken out of the main title and featured the words "moving" and "establishing" in the purpose of the measure.

Proponents of the measure now have 31 days in which to secure 17,888 names of voters in order to place the matter on the ballot next November. But this doesn't appear to worry them, as they say they can get more than that number of names and that the bill will be up to the electorate.

New license plates are now being issued, and these new plates will be a constant reminder for the next 15 days of the matter of placing some money on the counter in order to drive cars for another year. Only a few hundred licenses were issued the first day, but there will be plenty more.

FRAUD CHARGE IN SUIT OVER STOCK

Because of alleged fraud and misrepresentation, Sarah M. Hewitt, 70, yesterday filed suit in circuit court here against the Central Public Service company, Albert R. Peirce and company and F. E. Hughes, seeking recovery of \$2986 paid the first defendant for 52 shares of cumulative preferred stock.

Mrs. Hewitt declares that she and her husband, the latter now dead, bought the stock on frequent assurances of Mr. Hughes, salesman, that the money paid was really a loan, that it would pay seven per cent a year instead of three per cent which was being received from the savings department of a local bank. She also claims that the salesman guaranteed that on three days notice she could get her entire money refunded.

The plaintiff has tendered the stock back to the company which has refused to take it up, she says.

She asks payment in full for the stock, interest since December, 1931, and \$1000 for attorney's fees. Thirty-five shares were purchased March 7, 1931, and 17 shares November 18, 1931. No dividends have been paid by the stock since April 1, 1932. A Portland law firm is representing the plaintiff.
