

Tax is Voted For Parked Vehicles Selling to Public

DALLAS, July 20-An ordinance providing for the licensing of stands and parked vehicles on the streets of Dallas which are used to sell merchandise, where labor is being performed, or where services are contracted was passed Monday night at the regular council meeting. It provides for a tax of \$20 per year for a space 6x12 feet which will be marked off for the use of the merchant operating the stand.

This ordinance will not interfere with the working of the one providing for a license for pediwho plan to use such space for some time. The payments may be made in full for the year or in quarterly payments of \$5.00.
