

# HOLMAN-MEIER FEUD FLAMING

### Treasurer Says Governor is Overbearing and Rude; Policies Flouted

be in a neutral ground where all members of the board have a right to be, such as the board's office.

Continuing his account of the fight, Holman remarked: "He (Mr. Meier) treats me as he formerly treated Hal Ross and Tom Kay (former state treasurer). Governor Fearful of Marchers, Claims

The state treasurer intimidated that Mr. Meier feared for his life during the hunger march demonstration January 9.

At intervals during his remarks, Holman asserted that he is "not angry with the governor," and does not wish to deal in personalities.

"I am very sorry that in transaction of public business, officials degenerate to personal remarks."

Charges that recently circulated legislative "suggestions" attributed to the state treasurer were made with any intention of secret authorship were denied by Holman.

"Various members of the state legislature had approached me regarding public questions," Holman said. "The suggestions I put out were made in compliance with such requests and were distributed with no intent of concealment."

The treasurer conveyed the implication that his suggestions were made as a partial substitute for the governor's message to the legislature—not at that time delivered.

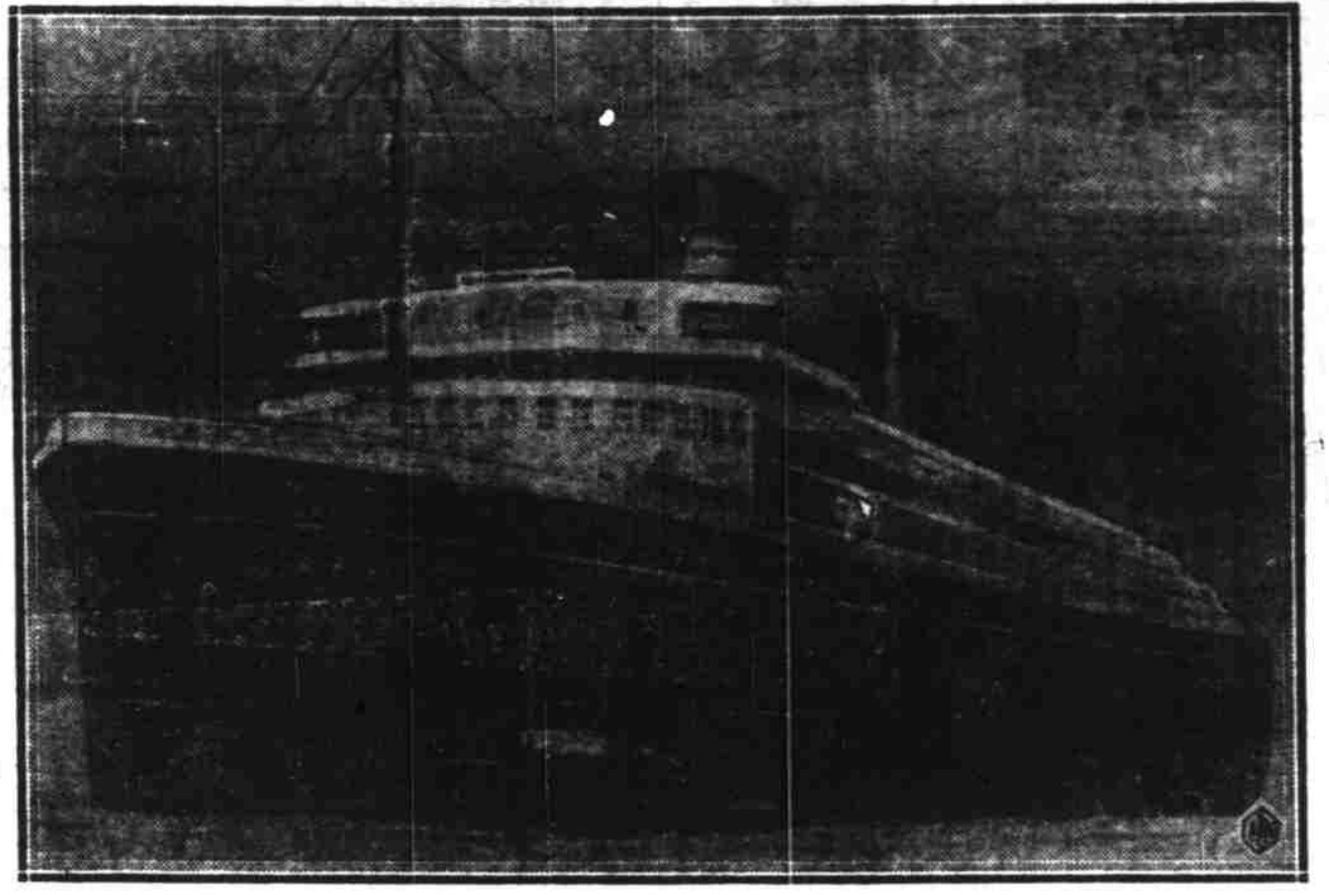
In making the charge that Governor Meier has departed from his former political creeds, Holman enumerated that:

The Burke bill seeking to provide funds for construction of a state owned power plant supply state institutions was defeated through the governor's influence. The governor has not adhered to a platform for public power development.

The economy program of the administration is not sincere in that the governor's office has only one over which he has sole control—is the "most extravagant in the state's history."

Holman announced that the "corrective legislation" he favors for scrutiny of the control board is already embodied in his published "suggestions."

# FRENCH LINER DESTROYED BY FIRE AT SEA



The French liner L'Atlantique, of 41,000 tons, the largest liner afloat, which was wrecked by fire in the English Channel while enroute from Bordeaux to Havre for overhauling. The ship carried 200 passengers, but twenty of the crew of two hundred were drowned or perished in the flames that swept the ship from stem to stern. The others were rescued by three freighters which rushed to the scene. This is the second French liner to burn within a year, the other being the Georges Philippart.

ceded by three times the "widest estimates" that first pictured a possible bond issue, the message said.

Although the one-half mill veterans' aid tax on property was eliminated in 1932 and 1933, it will have to be returned unless the legislature devises means of replacing it with other sources of revenue, Governor Meier said.

"An annual tax levy of one-half mill, or an equivalent revenue would appear to be a minimum."

"The commission has foreclosed on properties of approximately \$2,434,362 and it is expected that by the end of 1933, the delinquency will reach 40 per cent."

"It is my earnest recommendation that you make a thorough investigation of this commission with a view not only to substituting some other source of revenue for the present property tax, but also with a view of reorganizing the commission and reducing its operating losses to a minimum."

# Limits on Farm Help Advice of Incoming Chief

WASHINGTON, Jan. 17.—(AP)—The farm relief picture took on a totally new aspect tonight with members of congress expressing varied and conflicting reactions to President-elect Roosevelt's proposal that the "domestic allotment" bill, passed by the house, be confined to wheat and cotton.

Members differed as to whether the bill's chances for enactment would be enhanced or hindered under Mr. Roosevelt's plan but signs of fight appeared among congressional advocates of the five products which would be included—tobacco, hogs, dairy products, rice and peanuts.

# SECESSION SCHEME CAUSE OF FUROR

BISMARCK, N. D., Jan. 17.—(AP)—Whether a resolution recommending that 39 states secede from the union, introduced in the North Dakota senate by Senator W. E. Martin, should be published in that body's Journal precipitated a turbulent debate late today.

Charges were hurled across the assembly floor that the proposal "bordered on treason."

The motion to publish the resolution carried 28 to 20.

Previously, a motion to strike from the resolution a reference to the "Star Spangled Banner" was defeated by one vote.

The resolution, introduced Monday "recommends" 39 states secede, leaving the group of eastern states to form a separate country. The resolution says the 39 states would begin with the Star Spangled Banner and leaving them (the eastern states) the stripes which they so richly deserve.

# CAPITOL UNEASY AT TROUBLE IN ORIENT

WASHINGTON, Jan. 17.—(AP)—The possibility that fighting between Japan and China in the Jehol region may spread south of the Great wall of China and involve extensive foreign interests is causing increasing uneasiness in Washington official circles.

The administration is standing on its announced policy, to which President-elect Roosevelt said today he would adhere, of upholding the sanctity of all treaties, and no new approaches to the troubles in Manchuria are likely at the present time.

But a spread of the hostilities into the Tientsin and Peiping areas would bring new worries, and military developments in the more recent Japanese occupation of Jehol.

Below the Great wall in this territory lie great British coal and railway interests, and any military movements into the section almost certainly would involve Tientsin, the only important port in north China.

# Senate Confirms Appointments of Callister, Others

The senate yesterday confirmed the appointments of F. E. Callister of Albany as a director of the state board of higher education, and Drs. J. H. Rosenberg, Princeton, and H. H. Fossett and Robert Benson, both of Portland, as members of the state board of health.

The appointments were made by Governor Meier last March, and later were ratified by the senate committee on interim appointments.

Senator Duane cast the only dissenting vote against Callister's appointment.

# Effect of License Reductions to be Conference Topic

Members of the joint roads and highways committees of the senate and house will hold a conference with the state highway commissioners this afternoon in connection with proposed legislation affecting the operation of the state highway department.

Much of the discussion will be devoted to finances, and the possible effects of a material reduction in motor vehicle license fees.

# PERMANENT LIMIT ON DEBATE URGED

WASHINGTON, Jan. 17.—(AP)—Three proposals for modifying the senate's traditional rule of unlimited debate were inspired today by the filibuster against the Glass bank bill as aroused democratic leaders sought to break the rebellion within their ranks by cloture.

The deep schism on the democratic side of the senate was sharply outlined as 29 members of the party signed the cloture petition directed at a minority led by Long of Louisiana that has been blocking nearly all senate action for a week.

One proposal came from Senator Robinson, of Arkansas, democratic leader, who sought to make it possible to limit debate by a majority instead of a two-thirds vote.

Senator Tydings, (D., Md.), who revealed he was considering resigning in disgust at the senate's procedure, proposed a rule limiting debate for the remainder of the session, while Senator Hastings (R., Del.), suggested making a permanent limitation of two hours on speeches, subject to extension by the senate.

# UNION MOVIE MEN WIN UPON APPEAL

The state supreme court, in an opinion written by Justice Campbell, yesterday affirmed Judge Ekwall of the Multnomah county circuit court in a suit brought by Hattie Blumauer and others to enjoin the Portland moving picture operators protective union, from picketing the Capitol theater there. The lower court held for the defendants.

Justice Campbell held that organized labor has a right to use all lawful means to bring about reasonably desirable terms and conditions in the way of hours, pay and other conditions of employment.

"By banishing the pickets from the entrance of the theatre and confining them to a reasonable distance therefrom so they could not annoy or intimidate the patrons, the trial judge was doing all that was necessary to protect the rights of the appellants," Justice Campbell's opinion continued.

Justice Bailey, in his first opinion, reversed Judge Tucker of the Multnomah county circuit court in a suit brought by R. Thomas Carney and the Fidelity Phenix fire insurance company of New York against the LA Dee Logging company. This was an action to recover damages resulting from forest fires. The lower court held for the defendant corporation.

# Expenditures on Roads in County Shown in Report

Expenditures of \$119,428.36 were made on the county roads, bridges and ferry appropriation for 1932, a report compiled yesterday by the county clerk's office shows. This is but one of several road funds, and sums expended in it are segregated as follows:

Bridge maintenance, \$4,055.03; bridge construction, \$11,592.72; bridge patrolman's salary, \$33,832; bridge engineer, \$25 administration and general expense, \$14,810.61; equipment and operating cost, \$39,811.79; ferries, \$2,644.56; new equipment, \$4,766.94; right-of-ways, \$3,214.99; construction, \$37,500; engineering, \$171.90.
