whose testimony was mainly a repetition of that given by others. It was to Davis' home, up the street but near Newport's store, that Baughn went for a brief period. His actions there, however, frightened the witnesses, who resisted that he be taken away.

Constable Henry Smith, on cross examination, said that when he told Baughn that Robnett was dead the news nearly "got" Baughn and that Baughn nearly attempted to shoot him.

Attempt Impeachment Of Woe's Testimony

When Ethel Bowley of Detroit, first defense witness, took the stand, effort was made to impeach some testimony given earlier in the trial by Leonard Woe, who witnessed part of the trial in the Robnett yard and house.

When the state put Glebeler on the stand, the defense claimed him as a character witness for Baughn, but attempts to bring forth a character statement were virtually lost in cross examinations on definitions of "reputation" and "character."

The defense has about 10 witnesses all told. The climax of the trial is expected to come today when the defense presents as one of its witnesses Baughn's wife.

Testimony of Henley Baughn, Baughn's son who has lived with Robnett's sister since last July, started the day before yesterday, carrying on from the previous afternoon. No attempt, however, was made to bring out details of the actual fight, the matter being shown through him what led up to the fight. Only testimony dealing with the entire prelude and fight was that of Olive Shook-er, sister of Robnett.

withheld from the state by congress.

The legislature was urged to formulate a "definite policy which shall govern past loans and those which may be made in the future."

"Every receipt for funds advanced to the state by the reconstruction corporation carries the statement that the advance is made subject to the condition that 'the state of Oregon and the governor of said state shall give consideration to the possible need of providing funds by or within the said state or by within the municipalities or political subdivisions.' This clearly places upon the state the obligation to utilize its available resources through actions of the legislature," Governor Meier declared.

Thanks Members of Previous Committee

The first part of the message included a history of relief work undertaken to the present. The governor mentioned his state employment relief committee organized in 1931 and took "this opportunity of expressing my appreciation for the able, tireless and public spirited service they have rendered."

Members of the committee as named by the governor are Chairman Raymond B. Wilcox, Secretary Paul V. Maris, Mrs. W. W. Gabriel, Ray W. Gill, Victor P. Moses, Alex G. Barry and Ben T. Osborne. A recital of the committee's work with county relief agencies, in tabulation of data on unemployment and in actual relief rendered was included in the executive message.

Bridge of Native Bits Draws Sunday Tourists To Silver Creek Route

SILVERTOWN, Jan. 20.—Attracting considerable attention from tourists over the Silver Creek Falls road is the recently completed concrete bridge over Silver Creek, 14 miles southeast of Silvertown.

The bridge was completed shortly before the holidays but the approach is not as yet completed and the old bridge is still in use. The new one is thought to be the only one of its type on any Oregon highway. It is made entirely of native material. The railing is of rustic logs. The decking of two by two cedar laid lengthwise on a solid floor of 4 by 12s. It is 102 feet, center length, five foot walk on either side and a 24 foot driveway. The structure is built on a 24 degree curve with a two foot super, and built to fit with the road at this particular point-circle. The bridge itself is set on five concrete piers. Hodge Swart, Marion county engineer, designed the bridge and supervised its construction. A. G. Enright of Eugene was the contractor.

The bridge is practically the last connecting link of the loop of the picturesque highway known as the Silver Creek Falls state secondary highway which forms a loop from Salem out through Silvertown park back over the Waldo Hills and into Salem again.

Each Sunday sees dozens of tourists making their way into the hills to view the new bridge.

DALLAS, Jan. 20.—Polk county members of the Red Cross will meet Tuesday afternoon in Dallas, and complete the organization of a county chapter. Dr. A. B. Bigelow, field representative of the national Red Cross, who will tell of relief work under the supervision of the Red Cross and assist in the formation of the chapter.

For many years Polk county has been under the jurisdiction of Marion county, but for three years Dallas has functioned as an independent unit, but is now sponsoring the formation of a Polk county chapter to secure adequate supplies of flour, materials and clothing for the entire county. Each of the 20 county units with two or more members are asked to send two delegates.

tude of the state game commission relative to law enforcement under the state police department.

Figures were presented by Corrigan to show that in 1929 and 1930 the cost of conducting the law enforcement division of the state game commission was \$152,500. There were 707 convictions, at an average cost of \$215 per case.

In 1930 and 1931 the cost increased to \$156,431, with 650 convictions at an average cost of \$239 per case.

During the 1931-32 biennium, law enforcement under the state police cost \$137,489, with 1113 convictions at an average cost of \$123.

Corrigan said these figures spoke for themselves and an explanation or comment was not necessary.

Wagner replied that the sportmen of the state desired to have the law enforcement activities restored to the game commission and that bills providing for such action would be introduced during the present legislative session.
