# **BRANCH BANKS BILL UP TODAY**

### **Preliminary Vote Indicates** ft Will Pass; Zimmerman Is Chief Opponent

(Continued from page 1) ered to loan money to governmental units and to act as a depository for private funds. Perhaps because of general sentiment that the bank bill has littie change to pass, no opposition speakers appeared, although Senator Williamson, chairman of the banking committee, repeatedly appealed for negative arguments. F. E. Coulter of Portland open-

ed the verbal support for a state loan agency by citing the experience of the North Dakota state bank. That institution, Coniter said, despite hundreds of private failures. last year declared a dividend of 21 per cent to turn over to the state's general fund.

Press Was There. Despite Statements

J. E. Bennett, Portland city commissioner, seconded the first affirmative statements after first mistakenly taking "the press" to task for not being present at the meeting. Newspapers do not want to spread information regarding possibilities of a state bank, Bennett asserted.

"This period of hard time will not lift until we solve the breakdown of the present system of banking," Bennett declared. "Private banks largely were responsible for the economic debacle through cutting a credit of 80 billion dollars in 1920 to but 14 billion in last year."

Panic stricken bankers are shutting off credit, the life blood of commerce. Bennett said. The Portland official's talk, dealing largely with the federal reserve system was illustrated by large charts of figures.

A. E. Streiff of Multnomah county suggested that the feasibility of governmental banking already was adequately demonstrated in the success of the postat savings system.

#### Borrowing by State Cited as Argument

Streiff objected to the present situation under which Oregon is berrowing money from bankers to tide over periods of financial stringency, yet at the same time has even greater sums on deposit with other private banks. If the state handled its own funds, interest savings would amount to more than \$4,000,000 annually,

he said. Mrs. Max R. Charlton of Til- ing. lamook, former resident of North Dakota, opined that the success of the Dakota state bank was more outstanding than generally represented. She attributed the lack of a "farmers' revolt" in North Dakota to the stabilizing influence of the state bank. Dr. Albert Slaughter of Multnomah county, one of the framers of the Zimmerman bill, explained phases of the state problem. The blanks will be mailed to all former taxpayers next week. Portland residents may obtain additional blanks from the Portland office of the tax commission. Taxpayers outside of Portland may obtain additional blanks from their local assessor, bank or accountant or direct from the commission. The commission announced that inasmuch as funds are limited, it will probably not be possible to send auditors around the state.

The commission emphasized that there are no changes in the returns either as to rates or eremptions and urged that taxpayers file at the first opportunity so as to avoid the last minute rush and consequent delays.
