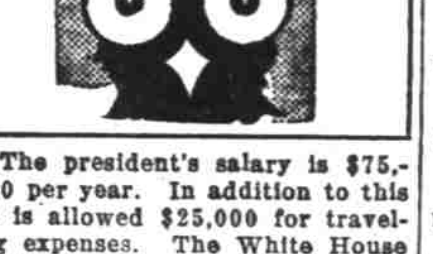

Rally Sets in Near Close; Record Lows Broken
CHICAGO, Feb. 27.—(AP)—Overwhelmed by a rush of selling to stop losses, quotations on all future deliveries of corn pitched heading downward just before the close today.

Wheat and other grains joined in the tumble started by corn. Every low price record reached this season was broken in the corn market, which showed a maximum fall of 1 1/2 cents a bushel today.

The selling stamped in corn was started by a commission house with many rural clients. Offerings from this source were interpreted by traders as an effort to liquidate holdings, and the market was caught bare of supporting orders.

At the last, however, some of the larger professional traders became active buyers, and corn rallied a little, with closing prices unsettled, 1/2-3/4c, under Saturday's finish, wheat 3/4c, down, oats 1/2-3/4c off.
