

MORTGAGE RELIEF MEASURE INVOKED

Endrigos Cite Reasons for Asking Delay; new law Application Seen

Fighting to save their equity in a 31-acre farm near Salem, Giuseppe Endrigos and his wife yesterday filed an answer to a mortgage foreclosure suit brought against them last month, in which they ask the court to delay judgment or else to name a minimum sum at which the sheriff may sell their acreage.

The Endrigos claim they purchased their place in 1929 from F. J. and Maud L. Dowe and paid in cash \$2500 on a \$4500 purchase price. For the balance they gave a purchase price mortgage. The Endrigos assert that prevailing low farm prices have made it impossible for them to pay their mortgage although they have kept up the place, planted a considerable tract of berries and made other improvements.

Should the place be sold at auction, the Endrigos claim their means of supporting three minor children will be lost and they will

be forced to depend upon charity. "Staying of execution was authorized by the legislature at its last session, when the trial judge was convinced debtors were doing everything in their power to pay and were keeping up the mortgaged property."

PORTLAND SPURNS DAYLIGHT SAVING

PORTLAND, Ore., May 4.—(AP)—The city council today "kicked the daylight" out of a move to introduce daylight saving in Portland in accordance with action taken in several Washington cities.

By a vote of three to two the council decided to let the sun continue to rise and set at its accustomed time, but the decision was rescinded only after an extended debate in which both sides of the question were fully presented.

SEATTLE, May 4.—(AP)—The daylight saving time movement gathered momentum in Washington tonight, as Aberdeen and Wenatchee had joined Seattle and Everett by ordering the clocks changed Sunday.

Of the other cities, most appeared likely to join the majority, whenever a majority became clearly defined, the only dissenting voice being that of Mount Vernon, where both business men and farmers were strongly against the idea.

Tacoma, Olympia, Hoquiam and other cities scheduled open hearings where both sides might be heard. Indications were Hoquiam would swing with Aberdeen, unless unexpected opposition developed.

JAMES THURSTON DIES, MONMOUTH

MONMOUTH, May 4.—(Special)—James Henry Thurston, 80, died at his home here today. He was born in Dunsmuir, Ontario, Canada, October 12, 1852, where he spent his early life. Before coming to Suver in 1908, he lived 25 years at Balsam Grove, Ontario, Canada.

H. of Independence.

A sister, Mrs. Minnie Murdock and three brothers, J. J. of Portland, R. M. of Newberg and E. A. of Eugene, survive also.

Argue Appeal of Power Measure Title on Monday

The state supreme court Monday will hear arguments on the appeal from the ballot title prepared by Attorney General Van Winkle for the so-called grange power bill.

The appeal was taken by Charles H. Wieder and E. B. Hall against Hal E. Hoss, secretary of state. Plaintiffs charged that the ballot title was misleading.

The grange power bill referendum was filed following a decision of the supreme court that

the emergency clause attached to the bill as passed by the 1932 legislature was unconstitutional.

The supreme court held that the power measure was subject to referendum despite that it carried the emergency clause.
