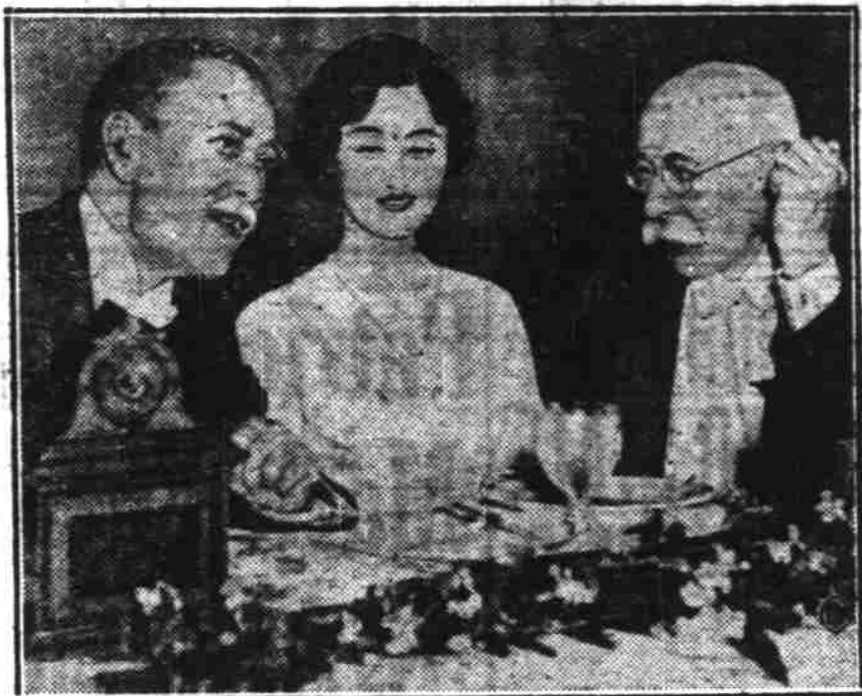

IDAHO GOES MOIST AS BEN ROSS SIGNS

BOISE, Idaho, June 21.—(AP)—Governor C. Ben Ross today signed the two bills passed by the special session of the state legislature legalizing sale of 3.2 per cent beer in Idaho and providing for regulating and taxing the beverage.

Signing of the bills made beer a legal drink in this state for the first time since 18 years ago the state adopted general prohibition laws.

Merchants had prepared in Boise and other places to begin pushing the foaming steins over the counter the instant the signature of the governor was attached, and within a few minutes after the news was spread over this city calls began coming into newspaper offices from people asking: "Where can we buy beer?"

No Leniency for Auto Owners is Officials' Word

No leniency will be extended to automobile owners who fail to obtain licenses for the next six months' period by July 1, officials declared here yesterday. The license fee for the six months' period is \$5.

Officials declared that under the new law applicants for automobile licenses were given approximately 20 days prior to July 1 in which to obtain their plates. They said the low fee also made it impractical to grant a moratorium beyond the license date.

Data Upon River Project Studied

No further word has been heard on the canalization project for the Willamette river, William P. Ellis, attorney who presented the case in Washington last month before the board of army engineers, reported yesterday. The evidence at the hearing was sent from Washington to the regional army engineer at San Francisco who is reconsidering the entire matter. He turned the project down originally after the district army engineer at Portland approved canalization.

6. That the committee of 50 receive a written reply to each of the above demands by noon, Friday, June 23rd.
