Betty was born at Tampa, Fla., in 1921 and came to Oregon with her parents in 1921. The family lived four miles east of Shaw, later at Rickley and last September moved to Salem. Betty was in the fifth grade at Lincoln school.

Anabel Lee Tooley was a daughter of Mr. and Mrs. Amon Tooley, 196 West Wilson street, and a sister of Doris, 5, and Patsy, 2. She was born in the Roseville district near here in 1924. She was in the fourth grade at Lincoln school.

Pioneer residents of Salem yesterday recalled that in 1879 two boys, Allie Jory, 10, and Ralph Jory, 5, were drowned near the same place where the two girls drowned last week. They were younger brothers of Oliver Jory of Salem.

COAST AIRMAIL TO CONTINUE IS WORD

WASHINGTON, March 12.—(AP)—A list of the curtailed schedules which the army will fly when its small planes go aloft again was made public today at the postoffice department along with the assertion the army had said it was prepared to fly the mails at the time the private contracts were canceled.

The new schedule, as made public by postoffice officials, includes: Boston to New York; New York to San Francisco, via Chicago and Salt Lake City; New York to Jacksonville; Washington to Atlanta; Chicago to Dallas, via Kansas City and St. Louis; Salt Lake to Seattle; Salt Lake to San Diego, via Los Angeles; Cheyenne to Denver and Chicago to St. Paul.

The postoffice department in the controversy over whether the army was consulted before the postmaster general canceled the contracts of private companies and gave their job to the service was made by Harlee Branch, assistant postmaster general.

AIR FORCE IS POOR SAYS OREGON MAN

WASHINGTON, March 12.—(AP)—Representative Rogers, (D-NH) today made public a letter written February 20, from Major Howard C. French, of the army air corps reserves, Portland, Ore., in which the condition of the army air defenses was described as "deplorable."

Major French's letter, urging upgrading of the army air force, said in part:

"The condition of the army air defenses is deplorable. Today the army starts to fly the air mail, as an army flier, except to be embarrassed at the poor demonstration they are sure to make.

"In this section of the country we are about to see mostly young graduates of the army air school start to fly the mail. These young men had had insufficient flying time for the job. All their flying time has been in fair weather in Texas and California. They have had virtually no night flying experience and will be entirely unfamiliar with mountainous country."

STATE LIQUOR ACT FACES COURT TEST

OLYMPIA, Wash., March 12.—(AP)—The first court hearing on a suit attacking the constitutionality of the new state liquor control act opened here today before Judge John M. Wilson of the Thurston county superior court.

The question before the court was whether to sustain or overrule the Washington liquor control board's general demurrer to a suit seeking an order permanently enjoining the board from carrying out the provisions of the act. A ruling either way will be appealed to the supreme court of the state.

The hearing is expected to be concluded some time tomorrow. Only attorneys representing the groups of druggists and hotel operators who brought the action were heard today.

Editor to Face Contempt Case

FRANKFORT, Ky., March 12.—(AP)—A motion to dismiss the complaint against Vance Armstrong, acting editor of the Louisville Courier-Journal charged with contempt of the house of representatives, was overruled tonight by Chairman Fred Genu of the special committee hearing evidence in the case.

GENERAL STRIKE IN CUBA NEARS CLOSE

HAVANA, March 12.—(AP)—A victory was claimed by government officials tonight in long standing strikes which have paralyzed vital services and caused disorders which today resulted in one death and injuries to five persons.

The cabinet ordered dissolution of all syndicates, but specified employers must respect all agreements and contracts effected during the history of syndicalism.

A palace spokesman said this action was agreeable to dock workers and a check by an Associated Press representative showed many were returning to their jobs today and tomorrow.

The new ruling allows reorganization of the syndicates as trade unions. The graphic arts group called the measure satisfactory and prepared to resume publication of newspapers after several days in which Havana had no papers.

40 Woodcutters Are Called for

The largest call for workmen in many weeks, aside from federally aided projects, was received at the national re-employment agency here yesterday, Manager D. D. Deason received requests for 40 men each for two woodcutting jobs and immediately began referring likely applicants to the employers. One of the jobs, seven miles west of Salem, will pay \$1.50 a cord, peeled; the other, near Dallas, \$1 a cord, unpeeled ash.

Rash Prisoner is Expected to Live

BOISE, Idaho, March 12.—(AP)—Arthur Silvia, 20, alias Bert Johnson, who attempted an escape from the prison early Sunday morning, today showed signs of improvement from the bullet wound inflicted by a guard who surprised him and he was considered likely to recover.

His companion in the attempted break, Francis Foster, 25, is in solitary confinement.

TRADE MISSION TO BE SENT BY SOVIET

MOSCOW, March 12.—(AP)—A soviet trade mission will be sent to the United States soon to investigate possibilities for increased commerce between the two countries offered by the new American export-import bank, recently chartered at Washington to facilitate Russian trade, it was learned today.

Official circles made it plain, however, the expected trade revival will be based on terms which communist leaders consider favorable to the soviets.

Russia will require, it was said, purchases here keep pace with sales of United States products in the soviet union. One fair-sized sale of \$250,000 worth of linen goods just has been made here by a New York firm, but there has been little other major commercial activity.

Trade talks will be held, also, between William C. Bullitt, new American ambassador, and soviet leaders here. Bullitt is convinced if the United States expects to get many orders from Russia in the future, American purchases of Russian products must be increased.

JOE MACK NAMED FULL-TIME COACH

ALBANY, Ore., March 12.—(AP)—Joe Mack, under whose leadership Albany college enjoyed its most successful basketball season in a number of years, has been selected head coach at Albany college, President Thomas W. Bibb announced today.

The Pirates won their last six basketball games including a victory over Oregon Normal.

Mack is a former student of Oregon State college where he was three-year letterman in baseball. He recently was assistant coach of freshman football and basketball at the state college. Here he will occupy a full-time position as instructor in physical education and supervisor of intramural sports.

Inquest Called Over Death of Roscoe Howard

MEDFORD, Ore., March 12.—(AP)—An inquest will be held here tomorrow over the death of Roscoe Howard, owner of the Dixie hop ranch near Grants Pass, who was killed when his automobile was struck by a Southern Pacific train at Rogue river.

Eye-witnesses heard the train whistle and saw Howard's machine jerk forward across the rails after coming to a virtual stop. The train does not stop at Rogue river.

The car was demolished and hurled from the track. The body was thrown clear of the car when it was flipped off the locomotive by a mail hook set in the right-of-way.

CLOUD PLACED ON CERMAK'S RECORD

CHICAGO, March 12.—(AP)—A flow of gold from Public Utilities company vaults into the pockets of Chicago office holders and politicians, through the medium of a junk dealer as "pay off man," was pictured today in a posthumously disclosed statement of Moe Rosenberg, west side political boss.

Rosenberg died last January in the midst of a federal investigation of his income tax payments. Just before his fatal illness he visited Washington with his attorney. The statement was reputed to be his explanation of why no return was made on some \$500,000 he received in two years from utilities company junk contracts.

The money, Rosenberg said, did not remain long in his hands but went to other politicians, several whom he named included in his list was the late Mayor Anton J. Cermak, who was down for \$95,000. State legislators and Chicago aldermen were others to whom Rosenberg said he distributed the largess of the utilities.

Many of the officials named by Rosenberg hastened to make emphatic denials. Others admitted receiving money, but insisted it was not as much as indicated by the junk dealer and that it was purely for campaign purposes.

Half Billion in Farm Loans Being Sought, Reports

Applications for nearly half a billion dollars in farm loans from Marlon and Polk county farmers have passed through the office of E. K. From the first of the year to March 6, 81 applications have been made for a total of \$411,350, from the two counties.

PROTEST IS FILED AGAINST CWA WAGES

Yesterday's protest did not surprise civil works officers here. Individual complaints against the wage curtailment have been numerous, especially among the rural crews, who work but 15 hours a week in contrast with those in the city on a 24 hour week basis, according to Frank Hrubetz, field man.

"None of the protests had been organized," Hrubetz said yesterday afternoon. "But a number of workmen on the rural crews — those who did not need work so badly — had quit their jobs. This actually helped us out because we had orders to reduce the number of men working for us in the county."

The wage recommendation to the state board for the Marion county area was based on 1929 union levels with a five day week. Common labor, for instance, would be raised to 50 from the present 40 cents an hour. Local officials believe that if the proposed increases are approved, they will be made retroactive to March 5, when the reductions became effective.
