Livermore made his start as a \$10-a-week broker's clerk in a Boston office. He made his first big "killing" in Anaconda Copper. Since then his activities have been the big moments in financial history. Livermore has been married three times. His first wife, the former Nettie Jordan, who divorced him in 1917. His next was Dorothy Fox Wendt, of Brooklyn, who won freedom in Reno in 1932. The third and present Mrs. Livermore was Mrs. Harriet Metz Noble, of Omaha. They were married about a year ago at Geneva, Ill.

CONGESTION AT TAX WINDOW DEPLORED

Lack of Space Makes Two Windows Impossible Sheriff Explains

Congestion at the tax collecting office in the county court house is bringing just about as many "pains in the neck" to Sheriff A. C. Burk, tax collector, as it is to the many persons who are forced to wait in line for long periods in order to make their payments. But he finds it impossible to set up two paying windows due to lack of room.

A long queue was in evidence from before 8 o'clock yesterday morning to 5 o'clock at night, when the sheriff says the law requires the office to be closed. At 5 o'clock last night, some 12 or 15 persons had to be turned away. The office continues open the entire noon hour, when other county offices are closed.

The real need is for two windows where payments may be made, or for a change in the system which would allow sending out of statements, Burk declares, but says he has been unable to bring about even the easier change.

Burk says he has made suggestions that the partition between the tax collecting office and the treasurer's office be blocked out and the two offices converted into one tax collection room, thus affording two entrances and room for two sets of books, but that this has been deemed not feasible because of the contemplated remodeling project for the courthouse. In event remodeling is accomplished, taxpayers will not have to put up with the present situation, as the plans call for plenty of room for this department.

"One reason there is so much inconvenience now is because the first tax collecting period which ordinarily ended May 15 has been crowded forward to March 15 for the first deadline," Burk says, and because of the interest discount, even more people are paying their taxes early."

Burk estimates that 80 percent of the people who have appeared to make any payment at all are paying the full year's tax in order to take advantage of the three percent discount. Many back taxes are also coming in, he says.

STAYTON, March 12. — What might have been a very serious accident occurred at the intersection of Water street and the Stayton-Kingston highway, about 1 p. m. Monday. Okie Snyder of West Stayton, accompanied by Charles Wise, was going west on Water street and O. G. Wengert, driving a gravel truck, was going south to the gravel bunkers when they collided. The Snyder sedan was rammed up against the heavy steel fence about the flax shed; a large pole with a guy wire used to support another pole across the street was cut off at the ground and the cable broke. Snyder's car was quite badly damaged. Wise was cut around the mouth and the others were not injured. State police were called. Townspeople have long objected to the rate of speed at which most of the gravel trucks travel through town.

First Woman Federal Judge



The appointment of Judge Florence E. Allen, of Ohio State Supreme Court to a Federal Circuit Court of Appeals, judgeship by President Roosevelt adds another "first" to the brilliant achievements of the noted woman jurist.
