

SPOKESMEN OF UNIONS GATHER

Meeting Monday to Decide Issue; Support Given Maritime Groups

Each local union was instructed to appoint, without delay, one member as its representative on the general strike committee. The resolution stated that "in case there is apparent need for action before all unions can take steps to engage in a general strike, that plans be laid immediately . . . for calling out the key trades such as the transportation group and other trades whose stoppage of work would tend to nullify the employment of any trades which might be delayed in taking action or which might be inclined to not join in a general strike."

The statement reiterated that the purpose of such a strike would be to lend support to the longshoremen and maritime unions in their strike which, since May 9, has paralyzed commerce on the Pacific coast.

The resolution stated further that "the proper organized labor authorities in this state be asked to immediately communicate with the organized labor movements in California and Washington and ask them to join with Oregon labor in a general strike . . ."

The two objects of the general strike would be: (1) That the longshoremen be conceded a system of hiring and dispatching halls in which the dispatchers will be members of the International Longshoremen's association; (2) That the right of collective bargaining through organizations of their own choosing be granted to all crafts now on strike that are affiliated with the American Federation of Labor, and that all unions be conceded the right to discipline their respective members.

A secondary statement issued from union headquarters declared "this assembly . . . sees in the recent moves of the police department . . . and of the sheriff's office a deliberate attempt to provoke the strikers into acts which will give excuse for a demand that martial law be declared."

INSURANCE FIRM IS SUING NELSON

DALLAS, July 6. — The Union Central Life Insurance company filed a complaint here today against Andrew Nelson, et al, in which the plaintiff seeks a judgment for a total of \$8715.92 plus interest, and \$600 attorney fees. The plaintiff also seeks to have a mortgage foreclosed and the property sold.

C. H. Gram, labor commissioner, filed a complaint against Wats, et al, in which he seeks to collect a bill for labor which was assigned to him. The complaint alleges that the defendants were doing business under the name of Lime Sales company, and that Homer A. White performed 36 days labor for them at a rate of \$3.20 per day. The complaint further alleges that in order to protect his right, White had filed a notice of mining lien on the property of this concern. The plaintiff seeks a judgment for \$77.40 plus interest, \$150 attorney fees, and ordering the foreclosure of the lien and the sale of the property.

NATIVE OF MARION COUNTY DIES AT 85

Besides the widow he is survived by a daughter, Mrs. Mabel McSorley of Salem; a son, Fred Cox of Independence; four stepchildren, H. E. Sawyer of Portland, J. D. Dodson of Corvallis, C. E. Dodson of Airlie, and Mrs. Marie Morgan of Portland; two brothers, Sol and Die Cox; 14 grandchildren and 12 great grandchildren.

Million in New Bridge Bonds to Be Given Monday

The state highway commission will meet in Portland Monday when the temporary bonds, involving a federal advance of \$1,000,000 for construction of the five Oregon Coast highway bridges, will be signed.

The bonds later will be deposited with the state treasurer, who will send his official receipt to the public works administration in Washington. The money then will be forwarded to Oregon, subject to expenditure by the state highway department.

The remainder of the \$5,602,000 loan will be obtained in installments. Highway department officials said the initial \$1,000,000 probably would arrive in Portland not later than July 20. Approximately \$800,000 will be employed in the construction of the five bridges, and the work will continue over a period of two years.

CAUSES OF SUDDEN FLOODS ARE CITED

Hedda Swart, Marion county engineer, believes that the reason the Willamette river rises about three times faster in high water seasons than it did in former years, has been discovered in the recent hearing on flood control.

After five hearings in the valley, Swart states that the phenomena may be caused in three ways. One reason is the cutting of timber in the mountains, which has caused a more rapid melting of snow during the spring months by exposing the water sheds.

Another cause is the construction of modern hard surface or gravel highways with modern drainage, causing an unobstructed flow of water along highways towards the streams.

Removal of brush and rail fences has also contributed to the easy flow of surface water.

POWER LINE TO GO INTO BOTTOM LANDS

Electrical development of the Willamette river bottom land district in this county, across the river from Independence was announced this week at Independence by the Mountain States Power company, electrical distributors for the territory.

Application to the war department for permission to construct an overhead electric distribution line across the Willamette river, 25 feet south of the existing ferry trolley cable, has been made and unless objections sufficient to alter plans are made before July 10, approval of the project will be made.

The power will be taken from the Independence power line and will extend for five or six miles through the district across the river, serving a number of large hop yards besides a number of families.

Preliminary construction of the transmission lines on the project is already under way, according to the power company.

EARTHQUAKE FELT, SOUTHERN OREGON

GRANTS PASS, Ore., July 6. — (AP) — Earth tremors were felt about 2:50 p. m., by several persons here and at points west to Brookings, according to telephoned reports from several persons.

Miss Fannie Abrams, chief clerk of the Shikyou forest staff here, reported feeling the tremor. She at once telephoned ranger stations through the forest and learned that the quake was felt at Galice and at Brookings.

The ranger at Brookings reported that suspended lights were still swinging from the tremor. MARSHFIELD, Ore., July 6. — (AP) — An earth tremor was felt at Crescent City this afternoon, according to reports received here, which indicated the quake was slight.

Perry Keeps English Net Crown Home

WIMBLEDON, England, July 6. — (AP) — Fred Perry, England's great "artisan" tennis player, rose to the greatest heights of his brilliant career today to present England with its own singles championship for the first time in 25 years. A. W. Gore was the last Englishman to win, in 1909.

Where John Bull's best "public school boys" had proved inadequate for a quarter of a century to cope with the invaders, Perry stepped in and crushed Jack Crawford, the world's No. 1 player from the end of the empire, Australia, just like breaking sticks — 6-3, 6-0, 7-5.

Perry, the boy who only a few years ago had to ask his employer's permission to get off work to play in park tournaments, proved himself the undoubted master of the present crop of amateurs, and possibly entitled to rank with the greatest of all time.

Improving with every match, George Lott and Lester Stoefen, American Davis Cup players, joined Helen Jacobs in the effort to salvage a few titles for the United States in other assorted finals tomorrow.

Strategy Board Will Study Outlook; Unions Defend Dock Men's Efforts

(Continued from Page 1) coast shipping siege May 9, for control of hiring halls. This is the principal demand on which mediation efforts have snagged.

A resolution presented by Edward Vandeleur, president of the council, and John O'Connell, secretary, which was adopted with a thunder of "ayes," declared the calling of the militia "subjected the striking marine workers and this port and community to the ignominy of being ruled by the military . . ." It termed the action of Acting Governor Frank F. Merriam in calling out the troops "unprecedented and ill-considered" and urged renewal of mediation efforts.

The discussion of a general strike, which also spread to Portland, came while the heavily-armed militia held the waterfront under a threat of hot lead and cold steel for the violent.

On the heels of all this, President Roosevelt's labor disputes board, which for days had worked in vain toward getting all sides together voluntarily for a settlement, suddenly decided to use its authority under the newly enacted congressional resolution covering employment controversies.

The board, invoking for the first time the provisions of the new law, announced it would hold public hearings beginning here Monday to determine issues, facts and practices in the controversy. It has the power to subpoena witnesses and records, and to act as arbitrator upon request.

Prior to ordering the hearings the board issued an appeal to both sides to accept arbitration.

The board announced all unions involved had indicated a willingness to submit to arbitration "but subject to certain conditions" and that employers had replied similarly. It said, however, the differences involved in the various conditions had made it impossible to proceed. The board asked for authority to decide the conditions under which arbitration could be started and asked all hands to cooperate immediately.

Scattered instances of violence were reported elsewhere on the coast today but the San Francisco waterfront, bristling with the steady threat of army machine guns, bayonets, rifles and nausea gas bombs, was ominously quiet.

Strikers, scattered in all-day rioting yesterday during which 22 others were killed by bullets and 32 others shot by police, appeared near the waterfront only in little groups and did not venture close to the national guard deadline. Unionists gathered in front of the longshoremen's hall, a block from the waterfront, however, and paid a silent but eloquent tribute to the two men killed.

Rates Cut for Water Users in Northern Plant

OLYMPIA, July 6. — Water rate revision orders against the Oregon-Washington Water Service company in Sedro Woolley and Burlington were issued Friday by the department of public works.

The orders cut fire hydrant rates in Sedro Woolley by \$765, but do not reduce any charges in Burlington. Existing flat rates for commercial service were eliminated in both cities and the company required to install meters for commercial and industrial customers by October 31, 1934.

Rate schedules were made effective July 1. Two previous orders against the utility's operations in Vancouver and Mt. Vernon reduced rates there to conform with schedules used in towns affected by today's orders.

A number of local citizens last year petitioned C. M. Thomas, utilities commissioner, to look into the rates of the Oregon-Washington Water Service company's operations in Salem, but to date no action has been taken.

FEW FARMERS TO INVOKE DEBT BILL

Bankruptcy Stigma to Deter Most, Fuhrer Declares Before Credit Group

Belief that but few farmers in the Willamette valley will take advantage of the privileges of the Lemke-Frazier farm moratorium bill, signed late last week by President Roosevelt, was expressed yesterday noon by Walter Fuhrer, candidate for state representative, in an address before the Retail Credit Association.

Fuhrer holds that not many farmers in this area will go through bankruptcy because of past stigma to that proceeding. He does believe, however, that throughout the country, many farmers will take advantage of the bill, due to conditions which the farmers face.

Fuhrer explained briefly working of the bill. After a farmer is adjudicated a bankrupt, and if he and his creditors can't reach agreement on amount due his creditors, he may petition the bankrupt court to have his prop-

erty appraised and have an appraiser take charge. Then there may be a proportion of the accounts, and if lien holders don't object, the farmer may buy the property back at the appraised price. In which event, there will be 1 per cent interest on the appraised price with 2 1/2 per cent of the principal due in the second and third year and 5 per cent in the fourth and fifth years, with the balance due in the sixth year. If this appraisal is not satisfactory to the lien holders, a victory to the lien holders, a year moratorium may be declared, with the debtor continuing in control of the property and at the end of the five years the debtor may pay to the court the appraised value of any or all of the property, depending upon how much he wants to keep.

Switching to legislative problems, Fuhrer believes taxation problems will be the most serious ones confronting the next legislature, and in these his greatest interest and studies lie.
