

SENATE, HOUSE CAUCUSES SET

Sessions Begin Monday at 10 A. M., Inauguration in Mid-Afternoon

Friends in the few choice positions the legislature affords.

The senate, always able to organize more quickly than the larger house, is to convene between 10:30 and 11 a. m. Noon-time adjournment will be taken after a resolution calling for a joint session has been passed. It is expected that the two bodies will reconvene in the house chambers by 2 p. m.

First order of business at the joint session, which will attract far more visitors than the legislative halls can accommodate, will be the canvass of the votes cast at the last election for governor. This routine task accomplished, the joint assembly, as prescribed by law, will hear the address of the outgoing governor, a speech which is expected to summarize the accomplishments of the four-year Meier regime.

The inauguration of Governor-Elect Martin will follow, with Chief Justice Campbell of the state supreme court administering the oath of office. The message of both the retiring and incoming governor are known to have been completed but their contents, closely guarded by the official families of both administrations, will not be available until given to the combined assemblies.

First Bills to be Those Sponsored by Martin

Unofficial reports yesterday were that the first bills to drop into the legislative hopper would be measures sponsored by the new administration. Included in the group may be bills giving legal standing to the Martin brain-trust for providing for reorganization of schools on the county unit plan and perhaps a bill for the inauguration of a cabinet form of government in the state. Copies of the bills were not available.

Sources close to the governor indicate that his message will be conservative in tone, bearing out his campaign promises that he would not embark the state into a program of big spending or of further going into debt. However, the new governor will undoubtedly reannounce his loyalty to the Roosevelt administration and will go down the line with the president for old-age pensions, unemployment insurance, work relief and other emergency enactments. In doing so Governor-Elect Martin is facing the dilemma of how to embark the state further into a round of activities and at the same time hold down cost.

The crowning event of the inauguration tomorrow will be the public reception held for Governor and Mrs. Martin. No private, dress-up affair, such as the inaugural dance of four years ago, but rather a come-one, come-all, reception which is expected to summon the largest crowd ever to pass through the statehouse in one evening.

The democrats—and they now seem to be a majority in Oregon—are coming, today and tomorrow—and they come to the capital with a song. For Old Man Oregon has seen a new light; he has again embraced the party of the donkey and men long out of power and a party which at times has had no more than one representative in a house of 60, is in control. No wonder that a special train is to come tomorrow, with a brass band and small wonder that there is excitement and suspense in Salem.

Tax Turnover is Made by County

A tax turnover of \$21,204 was made yesterday by the county treasurer's office, all the funds coming from 1934 taxes, a large part of which are being paid in 10 semi-annual installments. Some of the taxes are thought to have been collected as a result of the district attorney's office announcement that foreclosure proceedings would shortly be taken on taxes past due for 1930 and former years. Of the latest turnover, \$1187 comes to the city of Salem and \$2017 comes to school district 24.

ALL THE PRE-LEGISLATIVE session details are completed at the statehouse as far as the secretary of state's office is concerned. The Oregon code is on each legislator's desk. The official seating has been designated in printed charts with each member tagged so the most unacquainted lobbyist can find his man. The offices for the presiding heads of the senate and house are in order and committee rooms have been set up and designated throughout each nook and cranny of the statehouse.

Not until the caucus of the house and the caucus of the senate will this much debated dome topic be settled: Can men and women who have served the senate and house for many seasons in the past hold their jobs? Almost "historic" figures in the session are men like Albert Bede, reading clerk, and Joe Singer, sergeant-at-arms. Bede and Singer will be on deck early today seeing to it that the majority they claim in the house stand pat. The danger is that the democratic hunger-marchers will sweep the standbys out, and by a party favoritism rule break the pledges of the majority.

The furniture is already in the house Governor and Mrs. Martin will occupy on Lincoln street and some time this afternoon the Martins are expected to become official residents of the city. They would have come yesterday, it is understood, but preferred to remain in Portland until the Jackson day dinner was held. Mrs. Martin has expressed herself as delighted that she is coming to Salem to make her home. Since the adjournment of the congress and the Martins' return to Oregon, they have been residents of the Portland hotel.

Legal adviser in the office of the new governor will be E. S. Snedecor. Mr. Snedecor, who defeated in the primaries in Multnomah county, is known to be one of the most able representatives sent by that county to Salem. He stands high with his party and is close to the governor. His job is to persuade every bill which reaches the governor's office and to point out any flaws in its construction with the view to revisions before the measure is either vetoed or made into a faulty law. Some administrations in the past have hired two lawyers for this work.

The personal telephone Governor Meier installed between his Portland office and his executive office here is scheduled to come out tomorrow. It was paid for by the governor out of his own funds and was in constant use. The governor never failed to use it several times daily when he was away from Salem—which was the bulk of his time—and a host of statehouse employees learned how valuable it was in doing business with dispatch in Portland and as a consequence almost daily made a trail to the administrative offices to "use the free telephone". With the new governor making his home in Salem, there will be little official need for the line and the lesser lights under the dome will be forced to use their typewriters or charge the long-distance cost to their own departments.

Either the inclement weather of the last 24 hours or the rush of job seekers were him down—anyway John E. Cooter, slated for the speakership, was home yesterday and busy receiving treatment for a throat affliction which made him unable to keep a speaking engagement at the Jackson day dinner held last night for Governor-Elect Martin in Portland.

1/2 cup cream
1 cup lard or butter
2 eggs
1/2 teaspoon soda
2 teaspoons ginger

1/2 cup shortening
1/2 cup sugar
1/2 cup molasses
2 eggs
1 cup milk
1 teaspoon ginger
2 teaspoons cinnamon
1 teaspoon cloves
1 teaspoon nutmeg
1/2 teaspoon soda
1/2 teaspoon baking powder
1/4 cup raisins
1/4 cup nuts

Beat shortening and sugar and add well beaten eggs and molasses. Sift flour and spices, soda, baking powder and salt together and add alternately with milk. Lastly add raisins and nuts. Drop small portions from spoon on well-greased baking sheet. Bake 11 minutes in moderate oven. Makes about 5 dozen cookies.

1 lb. uncooked cubed ham
1/2 cup sliced celery
1/2 cup sliced onion, sliced lengthwise
1/2 cup sliced carrots
2 tablespoons molasses
Put ham and onions in a large greased kettle. Cook until the onions turn light yellow. Then add molasses and seasoning. Cover with boiling water and simmer for 1/2 hour, adding more water if necessary. Add celery and continue cooking for about 20 minutes. Thicken gravy. Serves six.

SCHOOL DISTRICT'S WARRANTS CALLED

Two blocks of Salem school district warrants were called in for payment, one Saturday and one Friday, it was announced at the office of School Clerk W. H. Burghardt yesterday. Total principal of these warrants amounted to \$18,208.09 and accrued interest to \$109.23.

The Friday call applied to warrants numbered 10-822 to 10-854, inclusive, which amounted in principal to \$16,401.09 and in interest to \$109.26. Yesterday's called warrants are numbered 10-855 to 10-872, inclusive, which in principal total \$1284 and in interest \$8.97.

These two calls left the district with approximately \$36,000 in warrants outstanding and marked "not paid for lack of funds." This amount will be booked by approximately \$22,000 early this week, however, when the mid-January payroll is made out.

AUXILIARY BACKING UP LEGION POLICY

TRAFFIC ARRESTS PROVE NUMEROUS

Police and Judge Carry Out Police Committee's Safety Policy

Traffic arrests by city police and accompanying penalties imposed in municipal court were numerous here yesterday, the first day following the city council police committee's declaration for enforcement of traffic laws and backing of police in this movement.

Eight persons were arrested on charges as follows:

No driver's license—Vernon Snoddy, Aumsville. On recommendation of the arresting officer, Judge A. Warren Jones dismissed the charge against Snoddy after he applied at the secretary of state's office for a license. When arrested he was enroute home on furlough from a CCC camp.

Schafer was fined \$1 and an order sent to the secretary of state's office reporting that he was not to be permitted to drive for 60 days. Downs and Kolha paid \$2.50 fines each. The others arrested yesterday were not to appear in court until this week.

Merrill H. Gallagher, 530 North 13th street, Dave Beugli, McMinnville and W. C. Pickens, 140 North 17th, all pleaded guilty yesterday to failing to stop and paid \$2.50 penalties. The operator of car number 18-286 paid a \$1 fine for a minor offense.

Out-State Autos Increase in 1934

Ten thousand more non-resident automobiles received temporary permits in Oregon last year than in 1933, figures released Saturday by the secretary of state's office showed. The total registration—92,268—almost equaled the mark of 93,142 set in 1931, the high point for non-resident permits issued in Oregon since the practice was started under state traffic laws. By far the greatest number of non-resident permits were issued to cars from California, 54,000 going to motorists from that state. Washington was second with 15,371 motorists getting permits.

Cars from the farthest distance brought to the state were one from China and one from the Dutch West Indies.
