MAKING OF POPPIES BEGINS THIS MONTH

Manufacture of the little red poppies which the American Legion Auxiliary will distribute on Poppy Day, May 25, will begin this month in the many veterans' hospitals and work rooms throughout the country. Mrs. Maurine Taw, poppy chairman of Capital Unit of the Auxiliary has announced. The work will give an opportunity to earn money and beneficial occupation to hundreds of disabled World War veterans.

The poppy making will continue through the winter and spring months and more than ten million of the paper replicas of the famous Flanders Field poppy are expected to be made before Poppy Day. Employment is given only to veterans receiving little or no government compensation and men with dependent families are given preference. The number of poppies each worker is permitted to make per day is restricted to 200 or less to spread the employment among the largest possible number and to prevent the disabled men from overtaxing their strength. At the average rate of one cent per flower, the earnings of the disabled men will total approximately \$100,000.

On May 25th, the Saturday before Memorial day, volunteer workers from the auxiliary will distribute the flowers on the streets of cities and towns throughout the country to be worn in memory of the war dead. Contributions received in exchange for the poppies will be used in the relief and welfare work of the American Legion and Auxiliary.

Dakotans to Be Colonized Here, Report

"Is there plenty of rain" in the Willamette valley? "Would a family need much land to make a decent living here?" "Could we buy improved land?" These and numerous other questions concerning the valley are asked by Ernest Sackreiter, North Dakotan, who expects this spring to be moved by the government from his drought-ridden farm to an Oregon acreage. The inquiries were addressed to C. W. Kauffer, Salem route seven to whom Sackreiter is related by marriage.

Sackreiter wrote that 350 families were to be sent to settle in Oregon around Tillamook, Eugene and Roseburg. The government was said to be planning to lend each family \$2000 to \$3000 with which to buy some 40 acres of land to make a new start at farming.

The letter to Kauffer inquired as to whether or not the land available here was improved or only logged-off stump land, as to its cost and as to the possibility of securing a few cows and poultry, and making a living from less than a 40-acre tract.

Kauffer referred the letter to the Salem chamber of commerce, believing that some of these settlers, at least, should be brought to this vicinity.

BROTHERHOOD DAY'S OBSERVANCE ASKED

Governor Martin yesterday called upon the people of Oregon to take part in the nationwide observance of brotherhood day. "I urge the people of Oregon to recall once more the early history of our country which was founded upon religious tolerance and freedom of worship," the governor declared.

"It is commendable that the leaders of the Protestants, Catholics and Jews are making this splendid effort to promote a feeling of good-will among the three major religious groups of the country. I hope the people of Oregon will join whole-heartedly in this national effort which will result in greatly improved civic relationship and cut the bonds of prejudice.

"Coming as it does so close to the celebration of the birthday of our first president, George Washington, verifies its possibilities. As you know, Washington exemplified this tolerance in his own daily life and urged the people of his day to broaden their minds to a greater understanding of the problems before them without allowing religious prejudice to warp their views. In commending to you the observance of Brotherhood day on February 24, I am supporting the principle so earnestly set down by Washington."

SECURITY PROGRAM STUDIED BY FORUM

Despite a stormy night the Tuesday night Forum which meets weekly at the YMCA, held its meeting last night, for the purpose of discussing the present economic security bills.

John Minto, non-practicing attorney and hop grower led the discussion. His talk brought out seven main points which the group as a whole accepted. They are: 1—Unemployment insurance; 2—Old age pensions; 3—Dependent child aid; 4—Earnings tax (for emergency fund) of 2 1/2 per cent on the employee and 2 1/2 per cent on the employer; 5—Social insurance board with controlling power; 6—Old age annuities; 7—Excise tax of 3 1/2 per cent on the payroll, (for pensions and unemployment insurance).

From this \$262,500,000 will be raised which must be matched by the several states to be used in states.

The total tax on the employer amounts to 5 1/2 per cent on the payroll and 2 1/2 per cent on the employee.
