In Compliance with the provisions of Section 59-1107, Oregon Code 1930, notice is hereby given that the County Court of Marion County, Oregon, will be in session at the Court House in the City of Salem, Oregon, in the Court Room thereof, on the 1st day of December, 1936, at the hour of 10 o'clock in the forenoon of said day, at which time and place opportunity for a full and complete discussion of the estimates of the amount of money proposed to be raised by taxation for the ensuing year will be given any taxpayer subject to such tax levy when made to be heard in favor of or against any proposed tax levies.
