Ghostly Drama To Be Offered

20-30 Sponsors "A Murder Has Been Arranged" at Leslie Oct. 29

Those eerie scenes which delighted audiences witnessing such mystery plays as "The Bat" and "The Gorilla" a few years ago are said to be outdone completely in "A Murder Has Been Arranged," ghost-mystery play which will be presented by the Salem Civic Players Friday night, October 29, in the Leslie junior high auditorium.

The play is sponsored by the Salem 20-30 club, with proceeds to be devoted to conducting a model airplane contest, winner of which will receive a course in flying instruction. Tickets may be purchased from 20-30 club members or from members of the Salem Civic Players.

As the title implies, "A Murder Has Been Arranged" differs markedly from the usual mystery play. One extremely novel feature is the fact that the murder is performed in full view of the audience, thus letting the customers in on the secret which puzzles the surviving members of the cast. But this is accomplished, it is claimed, without detracting anything from the suspense element in the plot.

An exceptionally able cast, all members of which have had considerable previous experience on the stage, has been selected by Miss Beulah Graham, director.

Cast Well Chosen

It includes several members who have appeared in previous productions of the Salem Civic Players, among them Guy Tucker who has the highly important role of Maxine Mullins, who stands to gain a fortune if Sir Charles Jasper doesn't live to his 40th birthday; Elsie Holman who has an eccentric character part; Ruth Versteeg, who had a leading part in the Elks' play last year, now plays the role of secretary to Sir Charles; and Ruby Curtis, who also has a character role.

New members of the players' cast include several who have appeared in Willamette university productions and other stage plays in Salem. The role of Sir Charles is taken by Herbert Rick, who was in the cast of "The Fool" recently staged by the First Methodist church young people; from that same group comes Al Tebault who plays Jimmy North, an enterprising and imaginative young man. Bertel Rand, who plays the part of an orchestra conductor, and Dorothy Renhard, romantic lead, are newcomers to Salem audiences but have had dramatic experience elsewhere. A woman "mute and mysterious" is played by Martha Jane Hottel, who was Willamette university exchange student in Hawaii two years ago.
