

Improving on their device, they fashioned a more efficient propellor blade, obtained a larger generator and were soon producing enough power to light the farm home of their father and drive the machinery. Soon orders were flooding in on them from other farmers who had heard of their invention. Today they have a thriving business and have placed more than 1,000,000 of their wind-driven power generator sets in rural homes.




