**War Repercussion**

CORVALLIS, Sept. 8.—(AP)—The effect of the European war on Oregon wheat production plans will be discussed at a state-wide meeting of wheat farmers next Wednesday at Pendleton.

A series of county meetings in the 17 wheat-growing counties of the state will be held starting September 18.

Whether to increase wheat acreage or stay within their agricultural adjustment administration allotments is the problem facing Oregon wheat farmers.

Will Steen of Milton, state AAA chairman, pointed out that Secretary of Agriculture Henry Wallace announced recently the present wheat surplus was more than enough to supply a year's needs.
